



#### Leadership (5)

WCC Corporate Board comprises the two joint managing directors, the strategic director of the people group and the chief fire officer. WCC Cabinet are involved in the decision making process for Corporate Board and the approval process for environmental policies. Three heads of service leading services having specific environmental focus (both internal and external) have been identified as top management for the EMS – they are:-

- The head of service for property services
- The head of service for community services
- The head of service for transport and economy
