#### 1. Background

The Voice of Warwickshire panel was launched in October 2021 when residents in Warwickshire were invited to register to join the panel. The panel will give residents in Warwickshire an opportunity to share their views on big issues in Warwickshire, like health and wellbeing, climate change and sustainability, community safety, education, transport, economic growth, inequalities and inclusion, and more.

This report summarises the results of the first survey sent to all panel members. This initial survey was intended to gather views on engagement with local government and Warwickshire County Council to date and understand panel members expectations for the panel.

The information gathered in this first survey will allow Warwickshire County Council to evaluate current views on engagement and how these may change over the 12-month trial period of the panel. This will enable us to assess what impact the panel is having and inform decisions as to whether the panel should be extended beyond the pilot period.

### 2. Method

An online survey was hosted on the Citizen Space 'Ask Warwickshire' site via a private link only available to panel members. All members of the panel were asked how they would prefer to complete surveys when they initially signed up to join the panel. The majority (>99%) of panel members opted to complete online surveys with five members advising they would prefer to complete paper-based surveys. Those opting for paper-based surveys were sent the survey along with a freepost return envelope. The other panel members were sent an email to participate in the online survey with two reminder emails being sent to those who had not yet completed the survey. In total, the survey was distributed to 982 members of the Voice of Warwickshire panel (note: the membership has since expanded slightly to 1,013).

The survey ran from 15 December 2021 to 17 January 2022. It was initially due to close on 31 December 2022 but was extended to give members recruited to the panel in late December 2021/early January 2022 an opportunity to respond. (Recruitment to the panel was reopened in mid-December to ensure the panel was as representative of the population of Warwickshire as possible.)

Appendix 1 provides the survey questions.

## 3. Key Messages

The survey received a total of 768 responses, representing a 78% response rate.

- In total, 72.3% (n=555) of respondents joined the Voice of Warwickshire panel to influence local decisions.
- Overall, 59.6% (n=458) of respondents have never taken part in any engagement activities with Warwickshire County Council.
- Almost 40% (n=307) of respondents agreed or strongly agreed that there are opportunities for them to share their views on issues that matter to them, whilst 36% (n=276) disagreed or strongly disagreed.
- Overall, 45% (n=344) of respondents disagreed or strongly disagreed that they are listened to in decisions that affect them.
- A total of 56.6% (n=435) of respondents either disagreed or strongly disagreed that they are informed of how their views and feedback have been used.
- More than half, 57% (n=438) of respondents, disagree or strongly disagree that Warwickshire County Council knows what is important to them. A further 34% (n=236) of respondents saying they neither agree or disagree.
- In total, 46% (n=352), respondents neither agree or disagree that Warwickshire County Council values residents' experiences and opinions.

## 4. Questionnaire results

There were 768 responses to the survey (including paper-based surveys), a response rate of 78.2%

#### 4.1 Respondent Profile

Figure 1 and Table 1 provide details on where panel members responding live in Warwickshire. The place of residence of panel members responding to the survey is broadly similar to the population of Warwickshire (aged 18+) with respondents from Warwick District slightly overrepresented.

Figure 1: Place of residence of respondents



#### 4.2 About your involvement

In this section of the survey respondents were first asked why they wished to get involved in the Voice of Warwickshire Panel. There were several options to select from and respondents were asked to select all options that were applicable. Figure 2 and Table 3 show a summary of responses to this question. The most common response was to influence local decisions with almost three quarters of respondents selecting this reason (72.3%, n=555).

Figure 2: Responses to "What made you want to get involved in Voice of Warwickshire?"



There was also an open text box for respondents to advise if they had any other reason for joining the panel. There were 41 respondents who added further reasons with several respondents giving more than one reason for joining the panel. Responses were themed and are summarised in Table 4 below.

The second question asked if respondents had previously taken part in any other Warwickshire County Council (WCC) consultation or engagement activities. There were 768 responses to this question.

The majority of respondents (60%) advised they had not previously been involved in any engagement activities run by WCC. Respondents were given several other options to select from and could select more than one response:

- Surveys
- Focus groups or workshops
- Community forums

- Webinars
- Not sure/ don't know
- Other

Those that had previously taken part in consultation and engagement activities were most likely to have completed surveys (23.3%, n=179) (Figure 3 and Table 5)

Figure 3: Responses to "Have you previously taken part in any other Warwickshire County Council (WCC) consultation or engagement activities?"




Respondents were given an open text box to respond if they had participated in any other activities. In total, 21 respondents advised they had taken part in other activities, a number of these were types of surveys or specific consultations but other methods included panels, COVID champions and meetings (Table 6).

The third question respondents were asked was "Have you previously responded to any Warwickshire County Council led consultation or engagement surveys on Ask Warwickshire (ask.warwickshire.gov.uk)?". There were 768 responses to this question, with 58% advising they have not previously responded to any Warwickshire County Council led consultation or engagement on Ask Warwickshire and further 28% saying they weren't sure (Figure 4).




Respondents were asked to think about how local councils currently gather and use the views of residents and to what extend they agreed with the following statements:

#### • There are opportunities for me to share my views on issues that matter to me

Almost 40% of respondents agreed or strongly agreed that there are opportunities to share their views on issues that matter to them, whilst 36% disagreed or strongly disagreed (Figure 5).

#### I am listened to in the decisions that affect me

Almost 45% of respondents disagreed or strongly disagreed with this statement whilst a further 43% of respondents said they neither agree or disagree that they are listened to in decisions that affect them (Figure 6).



#### I feel that residents are told how their views and feedback have been used

More than half (56.6%) of respondents either disagreed or strongly disagreed that they are informed of how their views and feedback have been used (Figure 7).

Figure 7: Responses to "I feel that residents are told how their views and feedback have been used"




Respondents were then asked to think specifically about Warwickshire County Council and were asked to respond to a couple of statements:

#### Warwickshire County Council knows what is important to me


Figure 8: Responses to "Warwickshire County Council knows what is important to me"

There were 768 responses to this part of the question. 57% of respondents disagree or strongly disagreed that Warwickshire County Council knows what is important to them with a further 34% of respondents saying they neither agree or disagree (Figure 8).

# Warwickshire County Council considers and values residents' experiences and opinions

Just over one-third (34.4%) of respondents said they disagreed or strongly disagreed that WCC considers and values residents' experiences and opinions with a further 46% of respondents saying they neither agree or disagree (Figure 9).

#### 4.4 Aims of the Voice of Warwickshire

The final question was in relation to the aims of the Voice of Warwickshire panel. The aims of the panel were outlined as - the panel will:

- Provide a representative voice from a wide cross section of the community in Warwickshire.
- Help Warwickshire County Council deliver the Council Plan by collecting views on key topics.
- Provide the Council with insight about residents' opinions to support and improve their decision making. It is not a decision-making body.
- Ensure members have a positive experience of engaging with the council about the things that are important to them.
- Help us to understand how a Residents' Panel can best be delivered and managed in the future.

Respondents were asked if they had anything additional they would like to see the Voice of Warwickshire residents' panel achieve. This was an open question with free text for the respondents to write their views.

Analysis was undertaken and themes based on qualitative comments are presented in Table 7. In total, 367 respondents gave a comment to this question, some providing multiple responses on what they would like the panel to achieve. The most common response was for the residents' ideas and views to be listened to and for residents to understand how their views and ideas had affected any outcomes within Warwickshire County Council.

Other themes mentioned by a smaller number of respondents included improving the management of highways (three respondents), improved partnership working (two respondents), improving the community's mental wellbeing (two respondents), respondents offering to use their skills and knowledge to assist the panel (two respondents) and using the panel to test out ideas and initiatives (one respondent).
