Executive summary

This survey sought to understand how panel members felt about engagement with Warwickshire County Council (WCC) and their thoughts on the Voice of Warwickshire (VoW) over the past year. Responses were compared to a previous survey completed by panel members in December/January 2022 where questions were the same or related.

There were 362 responses to the survey, a response rate of 36.9%. Respondents living in Nuneaton and Bedworth Borough were slightly underrepresented as were those aged 18-49. This was the 6th survey the Voice of Warwickshire panel completed.

Involvement with the Voice of Warwickshire panel

- Of the 357 respondents who responded to this section:
 - 46.1% (n=164) strongly agreed or agreed that they have been more involved in local democracy
 - 52.4% (n=187) strongly agreed or agreed that their voice had been heard
 - 72.7% (n=259) strongly agreed or agreed they had shared their experiences to help others
 - 78.1% (n=279) strongly agreed or agreed that they have found being a member of the panel interesting
 - 47.8% (n=170) strongly agreed or agreed that they had found out more about how the council works
 - 53.7% (n=191) neither agreed or disagreed that they had helped inform policy making
 - 57.7% (n=206) neither agreed or disagreed that they had influenced local decisions
- In the initial onboarding survey in January 2022, respondents were asked for the reasons they wanted to join the panel. In total 299 respondents answered both the initial onboarding survey 1 and this survey reviewing the Voice of Warwickshire. The below shows if respondents strongly agreed or agreed to a statement they had given as a reason for joining the panel originally.
 - 73.6% strongly agreed or agreed they had helped by sharing their experiences
 - 45.8% strongly agreed or agreed they had found out more about how the council works
 - o 76.9% strongly agreed or agreed they had found it interesting
 - 33.4% strongly agreed or agreed that they had informed policy making, a total of
 53.9% neither agreed or disagreed
 - 26.4% strongly agreed or agreed they had influenced local decisions, a total of 58.5% neither agreed or disagreed.
- Uncertainty as to how insight from surveys had been used was a common theme provided in free text comments about involvement.

• When respondents were asked if they had completed any additional engagement activities in the last 12 months 34.5% (n=118) advised they had not. A third, (n=114) advised they had completed surveys.

Views on engagement

- Of the 357 respondents who responded to the statements on Warwickshire County Council and how the views of residents are currently gathered:
 - 63.9% (n=228) strongly agreed or agreed that there are opportunities to share views on issues that matter to them
 - 17.9% (n=64) strongly agreed or agreed that Warwickshire County Council knows what is important to residents. A total of 50.4% (n=180) neither agreed or disagreed.
 - 38.1% (n=136) strongly agreed or agreed that Warwickshire County Council considers and values resident's experiences and opinions. A total of 40.1% (n=143) neither agreed or disagreed.
 - o 21.4% (n=76) strongly agreed or agreed that they are listened to in the decisions that affect them. A total of 53.1% (n=189) neither agreed or disagreed.
 - 25.2 (n=90) % strongly agreed or agreed that residents are told how their views and feedback have been used. A total of 38.7% (n=138) strongly disagreed or disagreed.
- When comparing the responses to this survey and survey 1 (for those respondents who answered both surveys), respondents were more likely to strongly agree or agree with all statements.

Aims of the Voice of Warwickshire panel

- Respondents were shown the original set of aims for the panel and were asked if they felt these had been achieved.
 - 61.2% strongly agreed or agreed that members provide a representative voice from a wide cross section of the community in Warwickshire
 - 59.8% strongly agreed or agreed they help Warwickshire County Council deliver the Council Plan by collecting views on key topics
 - 68.6% strongly agreed or agreed they provided the council with insights about residents' opinions to support and improve their decision making
 - 49.7% strongly agreed or agreed members have a positive experience of engaging with the council about the things that are important to them
- The most common theme provided in free text comments about the aims was a request to share survey results.

Comments and suggestions

 Respondents were asked if they had any comments or suggestions on the Voice of Warwickshire panel. The most common theme shared by 12.4% (n=45) of respondents was that they would like to know how the views they have given have been used by Warwickshire County Council.

The next year of Voice of Warwickshire

- 82.9% (n=300) of respondents indicated that they would like to remain on the panel for another year.
- The 64 respondents that said they no longer wished to remain on the panel were asked why; 32.8% (n=21) indicated they had only wanted to sign up for an initial 12 months, 26.6% (n=17) said that they do not have the time to commit and 21.9% (n=14) said they did not find the topics interesting.

What the survey results have informed

A common theme provided in free text comments was to share the survey results. All surveys have a report and a 'how your views have been used' document, which is published on the Voice of Warwickshire webpage and a link sent in an email to the panel. In response to the feedback provided in this survey the following will be introduced.

- All future surveys will have a dedicated email with an infographic to show the main headlines from the survey
- The infographic will link to the full report which is uploaded to the dedicated Voice of Warwickshire website
- The 'how your views have been used' document will be included on the email as a quick view and will also be uploaded to the Voice of Warwickshire webpage
- All reports will be issued to members, and we will seek to include a quote regarding the report and how the views will be used

Some members requested to understand the demographic make-up of the panel and whether it is representative of Warwickshire. This will be uploaded on the Voice of Warwickshire webpage to ensure members can see the overall demographics of the panel. Demographic information of those who replied to specific surveys will continue to be shown in the reports.

Background

The Voice of Warwickshire panel (VoW) was launched in October 2021 when residents in Warwickshire were invited to register and join the panel. The panel gives residents aged 18 and over in Warwickshire an opportunity to share their views on the big issues in Warwickshire, like health and wellbeing, climate change and sustainability, community safety, education, transport, economic growth, inequalities and inclusion, and more.

This report summarises the results of the sixth survey sent to all Voice of Warwickshire panel members. This survey was intended to gather panel members' views on their engagement with Warwickshire County Council and their thoughts on the first 14 months of the Voice of Warwickshire panel. This information was collected so that the current views could be understood as well as how these had changed since being a member of the Voice of Warwickshire panel. Where possible, results were compared to the results of an on-boarding survey carried out between 15/12/2021 and 17/01/2022.

Method

An online survey was hosted on the Citizen Space 'Ask Warwickshire' site via a private link only available to panel members. All members of the panel were asked how they would prefer to complete surveys when they initially signed up to join the panel. The majority (>99%) of panel members opted to complete online surveys with five members advising they would prefer to complete paper-based surveys. Those opting for paper-based surveys were contacted by phone and asked if they would like to complete the survey via the phone, due to the nature of the survey. The other panel members were sent an email to participate in the online survey with two reminder emails being sent to those who had not yet completed the survey. In total, an email with a link to the survey was distributed to 981 members of the Voice of Warwickshire panel.

The survey ran from 24 February 2023 to 12 March 2023.

Quantitative results have been analysed and open text responses have been themed. Where similar questions were asked these have been compared to results from the onboarding survey (Survey 1); overall 299 respondents answered both Survey 1 and this survey (Survey 6).

Appendix 1 provides the survey questions.

Results

There were 362 responses to the survey: a response rate of 36.9%.

4.1 Respondent Profile

Figure 1 and Table 1 provide details on where panel members responding live in Warwickshire. The place of residence of panel members responding to the survey is broadly similar to the population of Warwickshire (aged 18 and over) with respondents from Warwick District slightly overrepresented and respondents from Nuneaton and Bedworth Borough slightly underrepresented.

Figure 1: Place of residence of respondents



4.2 Involvement with the VoW panel


The initial section of the survey asked respondents about their thoughts on involvement with Warwickshire County Council following their membership of the panel. The first question provided the following statements:

- I have been more involved in local democracy
- As a member of the panel, I feel my voice has been heard
- I have shared my experiences to help others
- I have found being a member of the panel interesting
- I have found out more about how the council works
- I have helped inform policy making
- I have influenced local decisions

Respondents were asked if they agreed or disagreed with the statements; the results are shown in Figure 2. These questions were answered by 357 respondents. A total of 78.1% (n=279) respondents advised they strongly agreed or agreed that they have found being a member of the

panel interesting. Over half of the respondents 57.7% (n=206) advised they neither agreed nor disagreed when asked if they felt they had influenced local decisions.

Respondents were provided with extra space to explain their answer further; the themes of these responses are shown below in Table 3.

Comments mentioned by one respondent included: District and Boroughs not listening, have enjoyed surveys, equal opportunities for all District and Boroughs, would like face-to-face meetings, good to have a say, council forums should run, no progression of topics, and have felt a sense of belonging.

An <u>initial onboarding survey (Survey 1)</u> was completed by panel members in January 2022; a total of 768 panel members responded to the survey. Table 4 shows the responses to Survey 1 when respondents were asked why they wished to join the Voice of Warwickshire panel.



Figure 3 shows responses to Survey 1 when respondents were asked why they wanted to be involved in the panel compared to responses to Survey 6 which asked what they felt after being involved in the panel for 12 months. There were 299 respondents who replied to both surveys.

Whilst 76.3% (n=228) of the 299 respondents to Survey 1 advised they wanted to join the Voice of Warwickshire panel to influence local decisions, a total of 26.4% (n=79) advised they either agreed or strongly agreed this had happened. However, whilst 53.5% (n=160) of respondents to Survey 1 said they wanted to help by sharing their experiences, 73.6% (n=220) felt they had shared their experiences to help others.

The next question asked respondents if they had taken part in additional consultation or engagement activities with Warwickshire County Council. Respondents were asked to select all options that applied. A total of 34.5% (n=118) had not completed any extra engagement activities, 33.3% (n=114) indicated they had completed additional surveys (Figure 4).

Figure 4: responses to "have you taken part in additional consultation or engagement activities" (percentage of total responses)






Comments mentioned by one person include: a new job role which includes engagement, not been offered the opportunity, try to engage and Warwickshire Climate Alliance.

Respondents were asked the same question in Survey 1. Figure 5 shows responses from 299 respondents who completed both Survey 1 and Survey 6. In the initial survey, 1% (n=3) of respondents advised they had completed consultations. A total of 14.7% (n=44) of respondents when asked this question again in survey 6 advised they had responded to consultations.

Figure 5: Responses to "have you taken part in additional consultation or engagement activities" percentage of responses from survey 1 and survey 6 (percentage of total responses)




4.3 Your views on engagement

The next section of the survey asked panel members to think about Warwickshire County Council and how the views of residents are gathered and used and asked if they agreed or disagreed with the following statements:

- There are opportunities for me to share my views on issues that matter to me
- Warwickshire County Council knows what is important to me
- Warwickshire County Council considers and values residents experiences and opinions
- I am listened to in the decisions that affect me
- I feel that residents are told how their views and feedback have been used


Responses are shown in Figure 6. A total of 63.9% (n=228) respondents indicated they strongly agreed or agreed that there are opportunities to share their views on the issues that matter to them. Whereas 38.7% (n=138) disagreed or strongly disagreed with the statement 'I feel that residents are told how their views and feedback have been used'.

The same questions were also asked in the initial Survey 1. Figure 7 shows those that answered agree or strongly agree to the statements in Survey 1 and Survey 6. In Survey 1, 19.4% (n=58) respondents strongly agreed or agreed that Warwickshire County Council considers and values residents' experiences and opinions, in Survey 6, 40.1% (n=120) advised they strongly agreed or agreed to this statement. There was also an increase in the proportion of respondents who said that there are opportunities to share views on issues that matter to them.

Figure 8: Responses to "Warwickshire County Council considers and values residents' experiences and opinions" (percentage of total responses)




Figure 9: Responses to "Warwickshire County Council knows what's important to me" (percentage of total responses)




Figure 10: Responses to "I feel that residents are told how their views and feedback have been used" (percentage of total responses)




Figure 11: Responses to "I am listened to in the decisions that affect me" (percentage of total responses)






Figure 12: Responses to "There are opportunities for me to share my views on issues that matter to me" (percentage of total responses)



4.4 Aims of the Voice of Warwickshire panel

Respondents were then shown the original set of aims for the panel and were asked if they felt these had been achieved. A total of 68.6%, (n=244) of respondents agreed or strongly agreed that the aim "Provide the Council with insight about residents' opinions to support and improve their decision making" had been achieved. Fewer respondents agreed or strongly agreed that the panel had ensured panel members had a positive experience engaging with the council about the things that are important to them (49.7%, n=177).

Respondents were invited to add further comments about their responses. These have been themed as shown in Table 6. The most common theme was around sharing survey results; 27 respondents commented they would like the results of the surveys shared.

Comments made by one respondent included need to deal with short term, feel valued, panel needs to be bigger and how is this funded?

4.5 Comments and suggestions

The next section of the survey asked respondents if they had any comments to share on their involvement with the Voice of Warwickshire panel. Table 7 shows the main themes from respondents' comments. The theme mentioned by 45 respondents was they would like to understand how the views they provide are used by Warwickshire County Council.

Responses given by just one respondent included: it is well run, form to submit issues or suggestions, get more people involved, involved in projects early, more free text, more info on subjects, have not been listened too, not had time, not relevant and waste of money.

4.6 The next year of the Voice of Warwickshire panel

Respondents were asked if they wished to remain on the panel for the year ahead 2023/2024. A total of 82.9% (n=300) respondents advised they wished to remain on the panel, 17.1% (n=62) advised they did not wish to remain on the panel.

Respondents who said they did not wish to remain on the panel were asked why; 64 respondents answered this question (Figure 14). Almost one-third of respondents (32.8%, n=21) said they only wanted to sign up for an initial 12-month period, with 26.6% (n=17) saying they did not have the time to commit to the panel. Other reasons for not wishing to remain on the panel are listed in Table 8.
