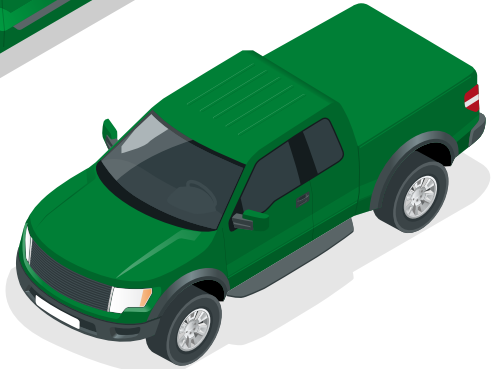


Vehicle Visits Application Form

For Warwickshire households whose only
vehicle is a van, pick-up or large 4x4.



**Household Waste
Recycling Centres**

This scheme applies to anyone who uses:

- a van
- a commercial type vehicle; or
- a pick-up or large 4x4



Small vans

Warwickshire residents can apply, whose only means of transport is a car-derived van or pick-up with a gross vehicle weight of up to 2.2 tonnes (this information can usually be found on the V5C vehicle registration document).

Successful applicants will be granted six visits - entitling you to deliver household waste in your vehicle up to six times a year.

You will not be eligible if you or other members of your household have access to a car in addition to a van or pick-up.

Twin cab pick-ups

If your household's only vehicle is a twin cab pick-up, you may qualify for four visits a year.

You will not be eligible for visits if you or other members of your household have access to a car in addition to a twin cab pick-up.

Terms & conditions

- *Transit type vehicles or any vehicle which has a legal gross weight of over 3.5 tonnes are not eligible*
- *Hired or borrowed vans are not eligible*
- *Vehicle visits do not allow you to dispose of commercial waste. All commercial waste is chargeable*
- *The issuing of visits does not allow unlimited quantities of waste to be deposited at household waste recycling centres*
- *Waste in trailers **will not** be accepted on any vehicle which qualifies*

(Chargeable if trade or commercial)



Car And Trailer Single Axle, Unbraked

No application required
(Chargeable if trade or commercial)
Up to 1.83m (6 feet) in length



Van Or Pick-up

Eligible to apply for 6 visits/year
(Chargeable if trade, commercial, or no permission for visit) *Up to 2.2 tonnes*



Caravanettes, People Carriers And Mini Buses

No application is required if seats are not removed. Otherwise 1 visit/year
(Chargeable if trade/commercial)



Twin Cab Pick-up Or Large 4x4

Eligible to apply for 4 visits/year
(Chargeable if trade, commercial, or no permission for visit). *Between 2.2 and 3.5 tonnes*



Commercial Vehicle

Chargeable where vehicle permitted on site (please check before arriving)
Over 2.2 tonnes



Van And Trailer

Chargeable where vehicle permitted on site (please check before arriving)



Pick-up And Trailer

Chargeable where vehicle permitted on site (please check before arriving)



Around 30% of all rubbish coming to Warwickshire's Recycling Centres could have been recycled at home.
