Advance Notice of Works: Kenilworth Road Cycle Route, Learnington Spa (K2L Section 1a)

Dear Sir/ Madam

Following the completion of Phase 1 of the new cycle route along the A452 Kenilworth Road and consultation on additional measures during June and July, I am now writing to give advance notice of planned works on Phase 2. These works are due to start on **4 September 2023** and are expected to be completed by the end of November.

These works include:

- Continuation of the cycle track along the east side of Kenilworth Road, south from No.30 Kenilworth Road to Binswood Avenue junction
- Full upgrade of traffic signals at the junction of Kenilworth Road and Lillington Avenue, including new cycle and pedestrian crossing facility on the east side
- Short sections of shared use footway/ cycle track on Kenilworth Road, Woodcote Road, Northumberland Road and Cloister Crofts
- Road hump/ priority crossing point on Cloister Crofts
- Signed on-road cycle route along Binswood Avenue and Beauchamp Road
- Double yellow lines on Kenilworth Road between Binswood Avenue and Gables House, just north of Northumberland Road

Works on Clarendon Avenue (near the junction with Beauchamp Road) may take place at a later date. These include a new crossing refuge, extension of cycle lane and removal of a small number of pay and display parking spaces.

To allow the works to be carried out safely, it will be necessary to introduce temporary traffic signals. These will include four-way signals at the junction of the Kenilworth Road and Lillington Avenue. Some temporary travel disruption can be expected during the construction period. Motorists may wish to consider changes to travel patterns to avoid delays - including changing travel times, using alternative routes where possible, car sharing and travelling by

other modes, including bus, foot or bicycle. We apologise in advance for any inconvenience this may cause.

The works will be undertaken by the County Council's Highways Contractor – Balfour Beatty Living Places. If you have any queries or concerns over the works while they are being carried out, please contact Balfour Beatty Living Places on 03452 415302.
