TRICS_® Land Use Categories and Use Classes

The table below displays the Use Classes Order (England) categories, as per the last amendment by the TCPA in September 2020, and the appropriate TRICS® land use sub-categories which match the individual use classes criteria.

Careful attention should be paid to the notes shown in red. Individual TRICS® site records may consist of developments meeting the criteria of a single use class, with some potentially coming under more than one use class depending upon certain criteria and perceptions of detriment (therefore being allocated the use class of "Not Known"), and some being incompatible with any use class (and therefore being allocated the use class of "n/a"). Sites classified as "Not Known" could be amended in the future should further clarification on parameters of definition for the more subjective use classes become available. For example, an industrial development could potentially be classified as B2 or E(g), but it is not the role of TRICS® to subjectively make this distinction on a site-by-site basis. It should also be noted that there will be instances where some TRICS® land use sub-categories contain some site records which meet use class criteria whilst other records do not. Only TRICS® land use sub-categories meeting use class criteria are displayed in the table below, with any sub-categories classified as "n/a" or "Not Known" being left out.

The full Use Classes Order document can be found within the Library module of TRICS® and is also accessible from within individual TRICS® site records. Users should always select their TRICS® sites for inclusion in trip rate calculations in line with the TRICS® Good Practice Guide.
