Guidance on handling admission requests for summer born children

Children are not required to attend school until they reach compulsory school age. Children born from 1 April to 31 August – known as summer born children – do not need to start school until the September after their fifth birthday, a year after they could first have started school.

Parents have the right to delay their child's entry until they reach compulsory school age. They do not require permission to make this decision. However, they **must** request their summer born child is admitted out of their normal age group at this point – to enable them to be educated in Reception, otherwise they will start school in year 1 with their chronological year group.

If a child is admitted to primary school out of their normal age group, the parent may make further requests, for example, when they transfer from primary to secondary school.

The admission authority of each school must make a decision based on the circumstances of the case and in the child's best interests.

It should be rare for an admission authority to refuse a parent's request for a summer born child to be educated in Reception rather than missing a year of education and going straight into year 1 when they reach compulsory school age.

As explained above, an admission authority may **not** decide that a child should start school before they reach compulsory school age (even if their previous experience is that summer born children do well, being educated in their chronological year group) - that is the parent's decision.

I confirm my child's birthday is between 1 April and 31 August and therefore they • are deemed summer born child for the purposes of admission to school. I have chosen to delay my summer born child's entry, by one year, until they are of • compulsory school age, and I am formally requesting for them to be educated outside of their chronological age group in Reception rather than them starting school in year 1. I understand educating my child outside their chronological age group will mean • they will be one year behind peers of their age for the duration that the agreement is in place within the relevant education setting. I have contacted the schools, I wish to apply for, and they have had an opportunity • to comment on the request for my child to be educated outside of their chronological age group. I have checked the admission arrangements for any own admission authority • schools and followed their process where different. I understand that all applications for school places will be processed in line with the • relevant school's admission arrangements. I understand any agreement allows me to apply for a place for my child in the • relevant year group, but this does not guarantee that a place will be offered if there are more applications that places available. I understand that: if a subsequent school does not agree to continue any educated out of year group arrangements, my child may be required to miss a year - for example moving from year 5 to year 7. my child will reach 16 in year 10 when means they would not qualify for any free 0 transport assistance in their final year. my child's wellbeing may be adversely affected (for example if their peer group 0 is developing at a different rate and they feel different). once my child has started school, the Headteacher is responsible for deciding 0 how best to educate my child and that on occasion, this may include deciding a child should be moved to a different age group. This means my child could be moved back to their chronological year group if there are sound educational reasons to do so. I accept that the decision to delay my child's start until they reach compulsory • school age is my parental right and not the recommendation of Warwickshire County Council or the DfE as it is believed most children will thrive if they are admitted to school in the September following their fourth birthday

In order for your request to be considered as part of the coordinated admissions process, this completed form <u>must</u> be received by the Admissions Service by 15th January of the year that the child would be due to start school, in their normal age group.

For example, children born between 01/09/2020 - 31/08/2021 are due to start school in Reception in September 2025. Requests to delay entry to September 2026, for children in this cohort, must therefore be received by 15^{th} January 2025,

Requests received after the deadline will not be considered until after National Offer Day

If the request is agreed that your child can be educated out of year group, you will need to:

- withdraw the application you made for a school place for the September after your child's fourth birthday
- make a new application for a school place for the September after your child's fifth birthday when the relevant round opens for applications

It is possible the school will not be able to offer your child a place. If there are more applications than places available, places will be allocated in accordance with the oversubscription criteria for the school. This is why it is important to consult all the schools you plan to apply for.

If your request is refused, you can either:

- accept the school place you are offered for the September after your child's fourth birthday your child will be admitted to the reception class
- make an **in-year** application for your child to start school in **year 1** in the September after their fifth birthday

If you decide to accept the reception place following your child's fourth birthday, you can:

- agree a part time timetable, with the school where you child has been offered a place, until later in the school year but not beyond the beginning of the summer term
- delay your child's school start until later in the school year, but not beyond the beginning of the summer term)

Any school place you were offered for the September after your child's fourth birthday will be lost if they do not take it up by the start of the summer term.

If you decide to have your child start school in year 1 following their fifth birthday, it is important you make an in-year application. It is possible that the year 1 class will be full so you may need to think about making an application to more than one school.
