Children with a Social Worker

Children with a social worker include those currently **Child in**Need or **Child Protection** and **those children who have had a**social worker in the last 6 years (Ever6 CWSW).




A team of experienced teachers work as Education Advisers under the leadership of the Virtual School Head.

Two of these education advisers share responsibility for children with a social worker in Warwickshire to promote a culture of high aspirations and offer strategic advice and support to schools and social workers for these children.

Early Education

3—4 year olds

Up to 15 or 30 hours of early education is available over 38 weeks of the year working families for children aged 3-4 years.



2-year olds

From April 2024 up to 15 hours will be available for up to 15 hours for eligible working families with a 2 year old.

Applications can be made from January.

Attendance

Raising aspirations

Children with a Social Worker are around 3 times more likely to be persistently absent from school and between 2 to 4 times more likely to be permanently excluded from school than their peers.



Virtual School works closely with the Warwickshire Attendance Service (WAS), schools and social workers to promote high expectations and help overcome identified barriers to support this cohort. Get in touch if you would like support for your Children with a Social Worker.

- Does it include offers of early help and multi agency working?

Progress & Attainment

Reaching full potential

'Children with a social worker are more likely to have experienced complex family circumstances'

(DfE 06.21).

These experiences can affect children's attendance, learning, behaviour and wellbeing.

On average, children with a social worker do worse than their peers at every stage of their education.

Education Health Care Plan Annual Reviews

Pupils with an Education Health Care Plan who are transferring into or between schools will need an EHCP Annual Review by **15th February 2024.**



Pupils moving from Secondary School to Post 16 or into Apprenticeships or between Post 16 institutions will need an EHCP annual review by 31st March 2024.

Questions to consider

- Has the SENCo planned EHCP annual reviews for any Children with a Social Worker?
- Have they remembered to invite the Social Worker?
