RE: **S278 WCC Highway works. A4177 Birmingham Road, Hatton**

I am writing with an update on the upcoming highway improvement works at the A4177 Birmingham Road, in connection with Taylor Wimpey's Union View development.

The works, which will be carried out by our contractor, McPhillips (Wellington) Ltd., are scheduled to commence on Monday 20th November 2023 and expected to last approximately 11 months. Any changes to that timescale will be conveyed to local residents.

The highway works will incorporate the following activities:

Widening of the A4177 and the construction of a pedestrian crossing point over the A4177 for the proposed development, and to support wider connectivity. A shared footway/cycleway. New and upgraded drainage works, road surfacing works, upgrading of existing street lighting and the installation of a new crossing facility which will incorporate a new refuge island.

Restrictions on working times.

We are fully aware that Birmingham Road carries a very high volume of traffic, and it will be important to consider how and when traffic management is introduced on the road. This is to manage the traffic flow and protect the travelling public and the work force at all times. The developer, the County Council (WCC) and the contractor have been working together to agree how best to manage traffic to minimise delays on the Birmingham Road and the surrounding road network. The impact on residents and businesses is a priority when planning for traffic management and the programming of the construction works in this area.

At present, the works are planned to be undertaken utilising 24/7 temporary traffic signals. These will be subject to manual control throughout the day, to more effectively respond to live traffic flows.

Permitted times for the construction works will be: 08:00 - 18:00 on weekdays, and between 08:00 - 13:00 on Saturdays, Sundays and Bank Holidays. All construction works carried out between these hours are limited to the permissible noise levels specified in the contract.

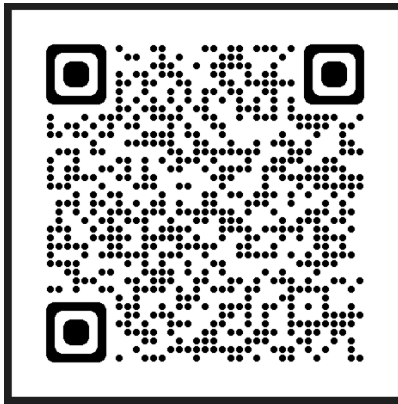
Some weekend working and weekend road closures will be permitted during the works; advance notice will be given and notice boards will provide information.

The roadworks will be suspended for approximately two-weeks to cover the Christmas and New Year period. By suspending the works from Friday 22nd December 2023 at 18:00 hours to Tuesday 2nd January 2024, disruption to the public using the highway on the A4177 Birmingham Road and the surrounding road network will be minimised. The site will be made safe during these periods and the existing 24/7 temporary traffic signals removed.
