S278 WCC Highway works - A4177 Birmingham Road, Hatton

As you will be aware, the S278 works to construct a new access on the A4177 Birmingham Road in connection with Taylor Wimpey's Union View development commenced in November 2023, with the works being carried out by our contractor, McPhillips (Wellington) Ltd.

The initial phase of the S278 works, which was completed before Christmas, involved surveying existing buried utilities within the existing A4177 carriageway, footway/cycleway and verge areas, together with commencing site clearance.

The next phase of the works will focus on upgrading sections of the existing highway drainage system, whilst also constructing new lengths of highway drainage.

Traffic Management on A4177 Birmingham Road

Taylor Wimpey, Warwickshire County Council and McPhillips (Wellington) Ltd have been working closely together to manage traffic during the works and to minimise delays to journey times on Birmingham Road and the surrounding road network.

We have listened to concerns from residents regarding journey times associated with the current traffic management arrangements and we continue to work with our contractor McPhillips (Wellington) Ltd. to improve on the operating pattern of both the 2-way and multi-phase traffic signals during the AM and PM peak periods.

Traffic management arrangements have been reviewed by Warwickshire County Council's Network Management Team to ensure disruption is minimised, whilst also ensuring safe working practices are maintained at all times.

As part of the traffic management monitoring process and in response to questions raised by local residents during the meeting held in October 2023, a summary of the key actions taken is outlined below:

- **'Keep Roundabout Clear'** signage has been installed on all three arms of the Birmingham Rd / Charingworth Drive roundabout.
- **'Residents Only'** signs have been installed on Winderton Avenue to deter motorists from using these routes as a 'rat-run'.
- **'Keep Junction Clear'** signs have now been installed at the junction of Ugly Bridge Road.
