RE: S278 Highway works - A4177 Birmingham Road, Hatton

I am writing to you to update you on progress with the S278 Highway Improvement Works at the A4177 Birmingham Road in connection with a new access to the Taylor Wimpey's Union View Development.

I would like to inform you that our contractor McPhillips (Wellington) Ltd., continue to make good progress on site with the construction works. The works to widen this section of Birmingham Road are scheduled to complete in Autumn 2024.

Traffic Management

The Phase 5 works to be carried out over the next 2 months, will continue to utilise 2-way traffic signals on Birmingham Road. Following completion of Phase 5 of the works there may be more opportunities to remove the temporary traffic signals at weekends when it is deemed safe to do so.

Warwickshire County Council continue to work closely with McPhillips (Wellington) Ltd., and their traffic management sub-contractor (Traffix), to keep delays and disruption to a minimum.

The contractor may also utilise weekend working on an ad-hoc basis, to ensure activities are completed in line with the approved construction programme. Any weekend working will be undertaken between 08:00-13:00.

In addition to weekend working, as mentioned in previous letters and resident forums, there will also be a need to carry out resurfacing works on Birmingham Road during nighttime closures, which are currently planned to take place over 7 nights in late October / early November 2024. Residents will be notified in advance of nighttime closures of Birmingham Road and information will be provided regarding the local diversion route.
