## **Advance Notice of Works**

### **A444 College Street Phase 1 – Proposed Signalised Junction**

#### **Greenmoor Road/Heath End Road/Bullring junction, Nuneaton.**

I am writing to give advance notice of the planned works in connection with the above project.

As part of the planned A444 Corridor, Warwickshire County Council will be installing a traffic signalised junction and carrying out other related works at the above location.

The works are programmed to start on 22nd July 2024, and are due to last for 6 weeks, not including the weekends ending 29th August 2024. The works will be carried out utilising a road closure on Greenmoor Road and multi way signals on Heath End Road and Bull Ring, the contractor will work between the hours of 08:00 hrs and 18:00 hrs each day and the closure on Greenmoor Road will remain in place during the 6-week period.

Alternative routes for diverted traffic will be clearly signed and access to properties/businesses within the site will be maintained throughout, where possible. There may be a short delay until it is safe for you to access/egress your property/business whilst the works are ongoing, however there will be marshals present on site to assist pedestrians through the works where needed and allow vehicle access. Please under no circumstances should you remove any barrier or cone. For your own safety and that of the workers on site, vehicle users and pedestrians are requested to please wait for the assistance of the marshals if access is required through the site and please exercise due care and attention when travelling through works.

On the reverse of this letter, you will find a plan showing the extents of the scheme. Warwickshire County Council's contractor, Balfour Beatty, will be undertaking these works and to help facilitate them, if you are a vehicle owner could you ensure that your vehicle is parked elsewhere, if possible, away from the carriageway to allow the contractor access to the site.

There will inevitably be some disruption to residents/businesses, but every effort will be made to keep this to a minimum.
