

**WARWICKSHIRE COUNTY COUNCIL**

**ROAD TRAFFIC REGULATION ACT 1984 AND HIGHWAYS ACT 1980**

**PROPOSED TRAFFIC REGULATION ORDERS / FOOTWAY TO CYCLE TRACK CONVERSION / ROAD HUMPS / NARROWING IN THE VICINITY OF ST JOHNS, WARWICK TOWN CENTRE**

**EXTENDED CONSULTATION PERIOD**

Warwickshire County Council propose to make the following Orders pursuant to the Road Traffic Regulation Act 1984:-

- (1) The Warwickshire County Council (St Johns and Smith Street, Warwick) (Prohibition of Right Turns) Order 2024; and
- (2) The Warwickshire County Council (Cross Street and St Johns Service Road, Warwick) (One Way Traffic) Order 2024;

The effect of these Orders is described (by approximate measurements) in Schedules 1 and 2 below.

Warwickshire County Council further hereby proposes, pursuant to the Highways Act 1980:-

- (3) to convert parts of existing footways in those lengths of road described (by approximate measurements) in Schedule 3 below into shared use footways/cycle tracks for use by pedestrians and cyclists;
- (4) to install road humps as described in more detail in Schedule 4 below; and
- (5) to narrow the carriageway as described in more detail in Schedule 5 below.

**Notice of these proposals were initially published on 27 June 2024. Warwickshire County Council has decided to re-publish these proposals to allow for an extended period in which representations may be submitted. Previously submitted objections/representations do not need to be resubmitted.**

**SCHEDULE 1**

**Proposed Prohibition of Right Turns**

**A429 Smith Street, Warwick**

From the A429 Smith Street (at its junction with St Nicholas Church Street / A429 St Johns), onto the A429 St Nicholas Church Street.

**A429 St Johns, Warwick**

From the A429 St Johns, onto the D4129 St Johns (service road).

**D4129 St Johns Service Road, Warwick**

From the D4128 St Johns (service road), onto the A429 St Johns.

**SCHEDULE 2****Proposed One Way Traffic Flows****D4090 Cross Street, Warwick – north-westerly traffic flow**

From its junction with A429 Smith Street, north-westwards for a distance of 29 metres.

**D4129 St Johns Service Road, Warwick – generally south-westerly traffic flow**

From its junction with D4128 The Paddocks, in a generally south-westerly direction for a distance of 83 metres.

**SCHEDULE 3****Proposed conversion of footways to shared use footways / cycle tracks****A445 Coton End, Warwick**

Northern side, from its junction with A429 Coventry Road, for a distance of 32.2 metres in a north-easterly direction.

**A429 Coventry Road, Warwick**

Western side, from its junction with A429 St Johns, for a distance of 67.7 metres in a northerly direction.

**A445 Priory Road, Warwick**

- (i) Northern side, from its junction with A429 St Johns, for a distance of 70.5 metres in a westerly direction.
- (ii) Southern side, from its junction with A429 Smith Street, for a distance of 18.1 metres in a westerly direction.

**A429 Smith Street, Warwick**

Northern side, from its junction with A445 Priory Road, for a distance of 13.5 metres in a south westerly direction.

**A429 St Johns, Warwick**

- (i) Southern side, from its junction with D4169 St Johns Court, for a distance of 10 metres in a south-westerly direction.
- (ii) Northern side, from its junction with A429 Coventry Road, for a distance of 34 metres in a south-westerly direction.
- (iii) Northern side, from its junction with A445 Priory Road, for a distance of 32.8 metres in an easterly direction.

**D4169 St Johns Court, Warwick**

Western side, from its junction with A429 St Johns for 36.6 metres in a south easterly direction

**SCHEDULE 4****Proposed Road Humps****St Johns Service Road, Warwick**

- (i) At its junction with A429 St Johns Road and being 7.1 metres (variable width) x 7.3 metres (length) x 0.075 metres (height)
- (ii) At a point approximately 61 metres south of its junction with D4128 The Paddocks adjacent to no. 23 and being 6.8 metres (variable width) x 4.8 metres (length) x 0.075 metres (height).

**The Paddocks, Warwick**

At its junction with D4129 St Johns (service road) and being 3.5 metres (variable width) x 4 metres (length) x 0.075 metres (height)

**SCHEDULE 5**  
Proposed Carriageway Narrowing

**The Paddocks, Warwick**

- (i) Northern side, at its junction with D4129 St Johns (service road) and being 0.93metres (width) x 5.60 metres (length)
- (ii) Southern side, at its junction with D4129 St Johns (service road) and being 0.71 metres (width) x 5.14 metres (length)
