**THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK) (CIVIL ENFORCEMENT AREA)  
(WAITING RESTRICTIONS, ON STREET PARKING PLACES AND RESIDENTS' PARKING)  
(CONSOLIDATION) (VARIATION Q) ORDER 2024**

**EXTENDED CONSULTATION PERIOD**

Warwickshire County Council propose to make the above-named Order, pursuant to the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places And Residents' Parking) (Consolidation) Order 2017, as described (by approximate measurements) in the Schedule below.

**Notice of this proposal was initially published on 27 June 2024. Warwickshire County Council has decided to re-publish this proposal to allow for an extended period in which representations may be submitted. Previously submitted objections/representations do not need to be resubmitted.**

Exceptions to any waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the proposed Order, together with a copy of an Order to be varied, plans showing the lengths of road affected and a statement of the Council's reasons for proposing to make the Order are available to view at the Main Reception at Shire Hall, Market Place, Warwick, and online on the Council's website at <https://www.warwickshire.gov.uk/news/20210/warwick-district>

**Proposed No Waiting At Any Time**

**Priory Road, Warwick**

- (i) Northern side - from its junction with A429 St Johns, westwards for 24.8 metres.
- (ii) Southern side - from its junction with Smith Street, westwards for 21.9 metres.

**St Johns (A429), Warwick**

- (i) Northern side - from its junction with Priory Road, eastwards for 30.9 metres.
- (ii) Southern side - from its junction with St Nicholas Church Street, eastward for 10.3 metres.

**St Johns (D4129 Service Road), Warwick**

Eastern side - from a point 63 metres south of its junction with The Paddocks, south-eastwards for 8 metres.

**St Nicholas Church Street, Warwick**

- (i) Eastern side - from its junction with A429 St Johns, southwards for 27.5 metres.
- (ii) Western side - from its junction with A429 St Johns, southwards for 22.8 metres.

**Smith Street, Warwick**

- (i) Northern side, from its junction with Priory Road, south-westwards for 25.2 metres.
- (ii) Southern side, from its junction with A429 St Johns, south-westwards for 22.9 metres.

Proposed Limited Waiting - Mon-Sat 9am-5pm (1 Hour, No Return within 2 hours)

**St Johns (D4129 Service Road), Warwick**

- (i) Two bays at its northern end - from a point 7 metres north of its junction with The Paddocks, northward for 5 metres.
- (ii) Eastern side - from a point 10 metres south of its junction with The Paddocks, southward for 53 metres

Proposed Blue Badge Holders Only

**St Johns (D4129 Service Road), Warwick**

Eastern side - from a point 71 metres south of its junction with The Paddocks, south westward for 6.6 metres.

Proposed Loading Only

**St Johns (D4129 Service Road), Warwick**

Eastern side - from a point 77.6 metres south of its junction with The Paddocks, south-westward for 8.6 metres.
