PROPOSED UPGRADE OF ZEBRA AND PUFFIN CROSSINGS ST JOHNS, COVENTRY ROAD COTON END JUNCTION, WARWICK

EXTENDED CONSULTATION PERIOD

Warwickshire County Council hereby gives notice of its intention to make the following changes to crossings, pursuant to section 23 of the Road Traffic Regulation Act 1984, as part of a proposed scheme to improve the St Johns junction, Warwick:-

- 1. Upgrade existing Zebra Crossing to a Puffin Crossing on A429 St Nicholas Church Street, near St Johns, Warwick.
- 2. Upgrade existing Zebra Crossing to a Puffin Crossing on A429 Smith Street, near St Johns, Warwick.
- 3. Upgrade existing Zebra Crossing to a Toucan Crossing on A445 Priory Road, near St Johns, Warwick.
- 4. Upgrade existing Puffin Crossing to a Toucan Crossing on A429 Coventry Road, at its junction with St Johns, Warwick.
- 5. Upgrade existing Puffin Crossing to a Toucan Crossing on A429 St.Johns, at its junction with A429 Coventry Road / St.Johns Court, Warwick.
