SCHEDULE 1 – VARIATION NO. 1 ORDER Proposed 40 mph Speed Limit (Freshfields)

B4632 Clifford Lane/Campden Road

From a point 755 metres south-west of its junction with the A3400 Shipston Road, south-westwards for a distance of 588 metres.

SCHEDULE 2 – VARIATION NO. 2 ORDER Proposed 40 mph Speed Limit (Roundabout)

B4632 Campden Road

From a point 143 metres north-east of the centre of the Campden Road/Strickland Drive/Lancaster Way Roundabout, south-westwards for a distance of 391 metres.
