ROAD TRAFFIC REGULATION ACT 1984

**THE WARWICKSHIRE COUNTY COUNCIL
(B4632 CAMPDEN ROAD, MAIN ROAD & STATION ROAD, MEON VALE / LOWER
QUINTON) (40 MPH SPEED LIMIT) ORDER 2018**

The Warwickshire County Council, in exercise of its powers under sections 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Save as provided in Article 2, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road described in the Schedule to this Order.
2. The provisions of Article 1 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
3. This Order may be cited as "The Warwickshire County Council (B4632 Campden Road, Main Road & Station Road, Meon Vale / Lower Quinton) (40 mph Speed Limit) Order 2018" and shall come into operation on the Fifth day of November Two Thousand and Eighteen.

SCHEDULE

1. B4632 Campden Road, Meon Vale / Lower Quinton

That length of road which extends from a point 67 metres south of its junction with Chatham Road/Wellington Avenue, in a northerly direction to a point 213 metres north of its junction with Station Road.

2. Main Road, Lower Quinton

That length of road which extends from its junction with the B4632 Campden Road, in an easterly direction for 271 metres.

3. Station Road, Meon Vale / Lower Quinton

That length of road which extends from its junction with the B4632 Campden Road, in a north-westerly direction for 923 metres.

The Warwickshire County Council, in exercise of its powers under section 84(1)(a) and (2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (and of all other enabling powers) and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. The Warwickshire County Council (Various Roads, District of Stratford on Avon) (Speed Limit) Order 2009 (as may have been varied by subsequent orders) (which said Order of 2009 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
2. In Schedule 1 to the Principal Order, delete item 34 B4632 Campden Road entirely, and replace with:-

"34.1 B4632 Campden Road/Clifford Lane

From a point 300 metres south west of its junction with Shipston Road, to a point 213 metres north of its junction with Station Lane.

34.2 B4632 Campden Road

From a point 67 metres south of its junction with Chatham Drive, Meon Vale, southwards to the Gloucestershire County Boundary.

3. This Order may be cited as "The Warwickshire County Council (Various Roads, District of Stratford on Avon) (Speed Limit) (Variation) Order 2018" and shall come into operation on the Fifth day of November Two thousand and eighteen.
