THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, DISTRICT OF STRATFORD ON AVON) (SPEED LIMIT) (B4632 CLIFFORD LANE/CAMPDEN ROAD VARIATION NO. 1) ORDER 2025

The Warwickshire County Council, in exercise of its powers under section 84(1)(a) and (2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (and of all other enabling powers), hereby make the following Order: -

- 1. The Warwickshire County Council (Various Roads, District of Stratford on Avon) (Speed Limit) Order 2009 (as varied) (which said Order of 2009 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
- 2. In Schedule 1 to the Principal Order, delete item 34.1 <u>B4632 Campden Road/Clifford Lane</u> entirely, and replace with:-

"34.1 B4632 Clifford Lane/Campden Road

From a point 148 metres south-west of its junction with the A3400 Shipston Road, south-westwards for a distance of 607 metres".

3. In Schedule 1 to the Principal Order, delete item 34.2 <u>B4632 Campden Road</u> entirely, and replace with:-

"34.2 B4632 Campden Road

- (i) From a point 262 metres south-west of the centre of the Freshfields Nursery School access, south-westwards to a point 213 metres north of Station Road.
- (ii) From a point 67 metres south of its junction with Chatham Drive, Meon Vale, southwards to the Gloucestershire County Boundary."
- 4. In Schedule 2 to the Principal Order, insert:-

"6. B4632 Clifford Lane

From a point 755 metres south-west of its junction with the A3400 Shipston Road, south-westwards for a distance of 588 metres."

This Order may be cited as "The Warwickshire County Council (Various Roads, District of Stratford on Avon) (Speed Limit) (B4632 Clifford Lane/Campden Road Variation No. 1) Order 2025" and shall come into operation on the day of Two thousand and twenty-five.
