ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (COUNTRY PARKS) (OFF-STREET PARKING PLACES) ORDER 2024

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 32 and 35 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), the Traffic Management Act 2004 as amended and of all other enabling powers, hereby makes the following Order:-

PART 1 COMMENCEMENT, CITATION AND INTERPRETATION

- 1. This Order shall come into operation on the Thirteenth day of May Two thousand and twenty-four and may be cited as "The Warwickshire County Council (Country Parks) (Off-Street Parking Places) Order 2024.
- 2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

"Annual Permit" means a permit issued under the provisions of Article 39 and which may be used by a Permit Holder for up to 12 months from the date of issue of the permit;

"Authorised Vehicle" means either an Electric Vehicle, a Motor Car, a Motor Cycle, an Invalid Carriage, a Minibus, or a Coach;

"Cashless Parking Service" means a service which enables a Driver to pay the Charge for Parking via phone in the manner as described on the sign Traffic Sign or Ticket Machine within the relevant Parking Place;

"Charge for Parking" means the charges for parking a vehicle in a Parking Place as described in Schedule 2 of this Order;

"Charge Certificate" shall have the same meaning as assigned to it in any Regulations made from time to time by the appropriate national authority pursuant to Part 6 of the 2004 Act;

"Charge Point" has the same meaning as in the Automated and Electric Vehicles Act 2018;

"Civil Enforcement Officer" means an individual employed by the Council (or employed by an agent appointed to act on the Council's behalf) in accordance with section 76 of the 2004 Act to enforce road traffic contraventions or a civil enforcement officer appointed by the Council (or appointed by an agent acting on the Council's behalf) in accordance with section 63A of the 1984 Act to supervise and carry out enforcement in respect of this Order;

"Coach" means a motorised vehicle constructed solely for the carriage of passengers and their effects and adapted to carry more than sixteen passengers, and not drawing a trailer;

"Country Park" means either Burton Dassett Hills Country Park, Hartshill Hayes Country Park, Kingsbury Water Park, Pooley Country Park, Ryton Pools Country Park or Stratford Greenway in the County of Warwickshire;

"Disabled Badge Holder's Bay" means a bay within a Parking Place which is provided for the leaving of a vehicle displaying in the Relevant Position a valid Disabled Person's Badge and indicated by markings on the surface of the bay or signed or otherwise indicated by signs or any other structure placed or erected in the Parking Place;

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Disabled Person's Vehicle" has the same meaning as in The Motor Vehicles (Approval) (Amendment) Regulations 2004;

"Driver" in relation to a vehicle waiting in a Parking Place, means the person driving or riding the vehicle at the time it was left in the Parking Place;

"Electric Vehicle" means a vehicle that is capable of being propelled by electrical power derived from a storage battery, which his adapted or suitable for use on a road and which is constructed to carry a load or passengers and of which the weight unladen:-

- (i) if it is constructed solely for the carriage of passengers and their effects, is adapted to carry not more than 7 passengers exclusive of the driver, and is fitted with tyres of such type as may be specified in regulations made by the Secretary of State, does not exceed 3050 kilograms; or
- (ii) if it is constructed or adapted for use for the conveyance of goods or burden of any description, does not exceed 3050 kilograms; or
- (iii) in a case falling within neither of the foregoing paragraphs, does not exceed 2540 kilograms;

"Electric Vehicle Bay" means a bay within a Parking Place which is provided for the leaving of an Electric Vehicle when such vehicle is connected to a Charge Point and where such Electric Vehicle is also permitted to be so connected;

"Enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;

"Enforcement Authority" means Warwickshire County Council;

"Minibus" means a motorised vehicle constructed solely for the carriage of passengers and their effects and adapted to carry between nine and sixteen passengers and not drawing a trailer; "Motor Car", "Motor Cycle" and "Invalid Carriage" have the same meaning as in section 136 of the Act;

"Owner" in relation to any vehicle means the person by whom such vehicle is kept and used;

"Parking Place" means the land described in Schedule 1 to this Order provided by the Council under section 32(1) for use as a parking place;

"Parking Space" means any space within a Parking Place which is marked out for the leaving of a vehicle of the class specified in this Order on the surface of the Parking Place or otherwise indicated by signs or any other structure placed or erected in the Parking Place;

"Penalty Charge" means the charges set by the Enforcement Authority from time to time in accordance with any guidelines given by the appropriate national authority pursuant to Part 3 of Schedule 9 to the 2004 Act which are to be paid not later than the last day of the period of 28 days beginning with the date on which the Penalty Charge Notice was served;

"Penalty Charge Notice" shall have the same meaning as assigned to it in any Regulations made from time to time by the appropriate national authority pursuant to Part 6 of the 2004 Act;

"Permit Holder" means a person to whom an Annual Permit has been issued;

"Reduced Penalty Charge" means the charges set by the Enforcement Authority from time to time in accordance with any guidelines given by the appropriate national authority pursuant to Part 3 of Schedule 9 to the 2004 Act which are to be paid not later than the last day of the period of 14 days beginning with the date on which the Penalty Charge Notice was served;

"Relevant Position" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"Ticket Machine" means any apparatus or device approved in accordance with section 35(3) of the Act and provided within a Parking Place;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised pursuant to or having the effect as though prescribed or authorised pursuant to section 64 of the Act of 1984;

"the 2004 Act" means the Traffic Management Act 2004;

- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order;
- 4. The prohibitions imposed by this Order shall be in addition to and not in derogation of any restriction, prohibition or requirement imposed by any Regulations or Orders made or having effect as if made under the Act of 1984, or by or under any other enactment.

- 5. Save where the contrary is indicated, any reference in this Order to:-
 - (a) this Order or another Order shall be construed as such a reference to this Order or, as the case may be, such other Order, as the same may have been or may from time to time be amended, varied or supplemented;
 - (b) a Statute or Regulation shall be construed as reference to such Statute or Regulations as the same may have been, or may from time to time be amended or re-enacted.

PART II USE OF PARKING PLACES

- 6. Each Parking Place is authorised to be used during the hours that the Country Park within which it is situate is open, subject to the following provisions of this Order, as a Parking Place for Authorised Vehicles (with the exception of Minibuses and Coaches which are not authorised to use the Parking Place at Stratford Greenway) but shall not be used by any other person for any other purpose or at any other times whatsoever.
- 7. Any right of passage within a Parking Place is available only to persons driving or being conveyed in an Authorised Vehicle and no rights of way whatsoever over the said Parking Place other than for the purpose of parking an Authorised Vehicle shall be deemed to have been granted by the Council by virtue of this Order.
- 8. Notwithstanding the provisions of Article 6 above, the Parking Places may only be used for the parking of Authorised Vehicles:-
 - (i) within individual Parking Spaces as may from time to time be marked out on the surface of the Parking Place (if any); or
 - (ii) within a Parking Place where there are no Parking Spaces marked out, in those areas as indicated by appropriate signage as being available for parking of Authorised Vehicles; or
 - (iii) as directed by a Civil Enforcement Office or an officer of the Council; or
 - (iv) in the case of a Motor Cycle without a side car, within an area specifically reserved for that purpose.
- 9. Where, within a Parking Place, there is a sign or surface marking which indicates that a Parking Space or an area within the Parking Place may only be used by a Disabled Person's Vehicle, the Driver of a vehicle shall not permit the vehicle to wait in that Parking Space or area unless a valid Disabled Person's Badge is correctly displayed on the vehicle in the Relevant Position.
- 10. Where, within a Parking Place, there is a sign or surface marking which indicates that a Parking Space or an area within the Parking Place may only be used by a parent with a toddler, the Driver of a vehicle shall not permit the vehicle to wait in that Parking Space or area unless a toddler is a passenger in the vehicle.

- 11. Where, within a Parking Place, there is a sign or surface marking which indicates that a Parking Space or an area within the Parking Place may only be used by an Electric Vehicle, the Driver of a vehicle shall not permit the vehicle to wait in that Parking Space or area unless the vehicle is an Electric Vehicle which is connected to a Charge Point.
- 12. Where a sign or notice is displayed prescribing a maximum height, width or length limit for vehicles permitted to use a Parking Place, no vehicle exceeding that height, width or length may use the Parking Place.
- 13. A person shall not drive a vehicle in a Parking Place at a speed exceeding that officially notified by way of signs or in absence of such signs at a speed exceeding ten miles per hour.
- 14. The Driver of a vehicle in the Parking Place shall comply with any instruction given by or on behalf of the Council or by a Civil Enforcement Officer, by direction signs or given in any other manner as to the route to be followed within a Parking Place and shall comply with any other road markings or signs within the Parking Place.
- 15. Where in a Parking Place signs are erected or surface markings are laid for the purpose of indicating the entrance to or exit from the Parking Place, no person shall drive or cause or permit to be driven any vehicle so that it enters the Parking Place otherwise than by an entrance or leaves the Parking Place otherwise than by an exit so indicated.
- 16. No person shall, except with the permission of the Council or a Civil Enforcement Officer, drive any vehicle into a Parking Place where there is exhibited at the entrance to the Parking Place a notice indicating that the Parking Place is full.
- 17. Any vehicle left in a Parking Place must be removed by the time the Country Park within which it is situate closes for that day.
- 18. No person shall, except with the permission of the Council or a Civil Enforcement Officer, use any Parking Place, or any vehicle within a Parking Place, for the purposes of:-
 - (i) sleeping or camping;
 - (ii) cooking;
 - (iii) servicing, washing, cleansing, constructing, maintaining or repairing any vehicle or any part thereof, including the draining or replenishing of fuel tanks, other than as reasonably necessary to enable that vehicle to be removed from the Parking Place.

- 19. No person shall, except with the prior written consent of the Council:-
 - (i) place or erect or cause to be placed or erected, any tent, booth, stand, building or other structure within a Parking Place;
 - (ii) light or cause or permit any fire to be lit within a Parking Place;
 - (iii) sell, hire or offer for sale or hire, any article, vehicle, service or food within a Parking Place;
 - (iv) solicit or beg for goods, services or money for charitable or other purposes within a Parking Place; or
 - (v) distribute or display, or allow to be distributed or displayed, any advertising material within a Parking Place.
- 20. No person shall bring, or permit or suffer to be brought, on to a Parking Place, any vehicle or trailer designed or adapted for the sale exhibition or display of food or other articles or services, except with the prior written consent of the Council.
- 21. No person shall use a Parking Place so as to prevent or obstruct access thereto or egress therefrom, or the use thereof by other persons, nor shall any person cause or take part in any gathering or demonstration within a Parking Place, or cause any unreasonable or unnecessary noise.
- 22. No person shall, within a Parking Place, commit any act which, if committed on a public highway, which constitute an offence under the provisions of the Litter Act 1983, or Part IV of the Environmental Protection Act 1990.
- 23. The driver of an Authorised Vehicle using a Parking Place shall stop the engine as soon as the vehicle is parked in an appropriate position in accordance with the provisions of this Order, and shall not start the engine except when about to change the position of the vehicle or to depart from the Parking Place.
- 24. No person shall leave or permit to be left in a Parking Place any vehicle having a secondary generating motor for the purposes of a refrigeration unit or any other purpose unless he ensures that at all times whilst the vehicle is so left the secondary generating motor is not in operation.
- 25. No person shall permit any vehicle left in a Parking Place to be used in such a manner so as to generate excessive noise or so as to cause a nuisance whether by fumes or otherwise to other lawful users of the Parking Place or the Country Park or residents living near to the Country Park.
- 26. No person shall use an area within a Parking Place which is signed or marked for the parking of vehicles for the playing of any game, for roller skating, skateboarding nor riding any pedal cycle thereover.
- 27. No person shall cause or permit the contents of any closet, urinal, lavatory, basin or sink or of any tank into which such a closet, urinal, lavatory, basin or sink drains to be discharged or to leak on to a Parking Place or into the drainage system of the Country Park.

- 28. No horn or other similar instrument may be sounded on a vehicle using a Parking Place except when the position of the vehicle is about to be changed or the vehicle is about to depart from the Parking Place.
- 29. No person shall in a Parking Place use any threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.
- 30. No person shall do anything to interfere with the use and enjoyment of the Parking Place by other users of the Parking Place or the Country Park.
- 31. (1) If in any case, owing to the presence of an Authorised Vehicle in a Parking Place, an accident occurs whereby personal injury is caused to a person other than the Driver of that vehicle or damage is caused to a vehicle other than that vehicle or to any other property whatsoever, the Driver of the Authorised Vehicle shall stop and, if required so by a Civil Enforcement Officer or an officer of the Council or any other person having reasonable grounds for so requiring, give his name and address and also the name and address of the Owner and the identification marks of the vehicle.
 - (2) If in the case of such accident as aforesaid, the driver of the Authorised Vehicle for any reason does not give his name and address to any such persons as aforesaid, he shall report the accident to a police officer as soon as reasonably practicable and in any case within twenty-four hours of the occurrence thereof.
- 32. Any person who wilfully or carelessly damages in any way or interferes with the fabric or structure or equipment of a Parking Place shall be guilty of an offence under this Order and in addition to the penalty provided by the Act, shall be liable for the cost of repair of the damage.
- 33. The Council shall not be responsible for any loss or damage to any vehicle, or to anything contained therein or thereon, from any cause whatsoever whilst any such vehicle is entering, within or leaving a Parking Place.
- 34. (1) Except in the circumstances described in Article 34(3) below, the Driver of any vehicle parking that vehicle in a Parking Place shall pay the appropriate Charge for Parking.
 - (2) The Charge for Parking shall be paid either:-
 - (a) by the insertion in the Ticket Machine within that Parking Place of a coin or coins of the appropriate denomination making up the full amount of the Charge for Parking for the entire period in which the vehicle is being left in the Parking Place where that Ticket Machine accepts cash payment; or
 - (b) by making a valid debit or credit card or contactless payment in any form accepted by the Ticket Machine relating to that Parking Place for the full amount of the Charge for Parking for the entire period in which the vehicle is to be left in that parking place where that Ticket Machine accepts debit card, credit card or contactless payment; or

- (c) by using a Cashless Parking Service to pay the full amount of the Charge for Parking for the entire period in which the vehicle is to be left in that Parking Place.
- (3) A Driver who holds a current and valid Annual Permit for that Parking Place shall be exempt from payment of the Charge for Parking in that Parking Place PROVIDED THAT the Annual Permit is only used for an Authorised Vehicle that bears the registration number which was specified on the application for the Annual Permit or on the driver's online permit page on the day of parking the vehicle in the Parking Place.

PART III SUSPENSION OF PARKING PLACES

- 35. Any person authorised by the Council may suspend the use of a Parking Place or any part thereof whenever he consider such suspension reasonably necessary for the purposes of:-
 - (a) facilitating the movement of traffic or promoting its safety;
 - (b) any building operation, demolition or excavation in or adjacent to the Parking Place or the maintenance improvement or reconstruction of the Parking Place or the Country Park in which it is situate;
 - (c) on any occasion on which it is likely by reason of some special attraction or event that the Parking Place will be thronged or obstructed;
 - (d) to enable the Parking Place to be used for or in connection with a special event; or
 - (e) for any other purpose which the Council thinks fit.
- 36. Any person suspending the use of the Parking Place or any part thereof in accordance with the provisions of Article 35 above shall thereupon place or cause to be placed in or adjacent to that Parking Place or the part thereof the use of which is suspended, a notice or Traffic Sign indicating that the use of that Parking Place or part thereof is suspended and that parking by vehicles is prohibited.
- 37. The Council at its discretion may suspend the use of any part of a Parking Pace and thereafter may designate that part of such Parking Place be reserved for the parking of vehicles used by or engaged in the operations of the Council or other organisation, or in connection with the operation and maintenance of the Parking Place, and any part of the Parking Place so designated shall be marked so as to identify that it is reserved for vehicles engaged in such operations.
- 38. No person shall cause or permit a vehicle to be left in any Parking Place or any part thereof during such period as there is in or adjacent to that Parking Place a notice or Traffic Sign placed in pursuance of Articles 36 or 37 above.

PART IV ANNUAL PERMITS

- 39. The Owner of an Authorised Vehicle (with the exception of a Coach) may apply to the Council for the issue of an Annual Permit for the leaving of that vehicle in a Parking Place and any such application shall be made online through the Council's website (or using another method as may be specified by the Council from time to time), and shall be accompanied by the appropriate remittance for that Annual Permit as specified in Schedule 3 of this Order.
- 40. On receipt of an application made under paragraph 39 of this Article, and of the relevant fee, the Council or its agent shall issue to the applicant an Annual Permit or virtual permit for the leaving of the vehicle specified in the application in any Parking Place to which such application relates, by the Owner of such vehicle, or by any person using such vehicle with the consent of the Owner other than a person to whom such vehicle has been let for hire or reward.
- 41. Upon the issue of an Annual Permit by the Council or its agent pursuant to Article 40 above and receipt of the correct fee, the Permit Holder's and those of the vehicle to which the Annual Permit applies will be recorded in the Council's permit database and the Annual Permit will be deemed valid and live.
- 42. The Council may at any time require an applicant for an Annual Permit, or a Permit Holder, to produce to an officer of the Council such evidence in respect of such application or Annual Permit as it may reasonably require to verify any information given to it.
- 43. (1) A Permit Holder may surrender an Annual Permit to the Council at any time and shall surrender an Annual Permit to the Council on the occurrence of any of the events set out in paragraph (3) of this Article.
 - (2) The Council may by notice in writing or by electronic means served on the Permit Holder at the address or email address shown by that person on the application for the Annual Permit or at any other address believed to be that person's residence, withdraw an Annual Permit if it appears to the Council that any one of the events set out in paragraph (3) of this Article has occurred and the Permit Holder shall surrender the Annual Permit to the Council within 48 hours of the receipt of such notice.
 - (3) The events referred to in the foregoing provisions of this Article are:-
 - (i) the Permit Holder ceasing to be the Owner of the vehicle in respect of which the Annual Permit was issued;
 - the vehicle in respect of which such Annual Permit was issued being adapted or used in such a manner that it is no longer falls within the definition of an Electric Vehicle or a Motor Car or a Motor Cycle or an Invalid Carriage in this Order;
 - (iii) the issue of a duplicate Annual Permit by the Council under the provisions of Article 44 below;
 - (iv) the Annual Permit being used in such a manner which contravenes the provisions of this Order.

- (4) An Annual Permit shall cease to be valid on the day following the expiry date specified thereon or on the occurrence of any one of the events set out in paragraph (3) above of this Article, whichever is the earlier.
- (5) Where an Annual Permit is issued to any person upon receipt of a payment and the payment is subsequently dishonoured, the Annual Permit shall cease to be of any effect and the Council shall by notice in writing served on the Permit Holder by sending the same by the recorded delivery service or by electronic means to the Permit Holder at the address or email address shown by that person on the application for the Annual Permit or at any other address believed to be that person's place of residence, require that person to surrender the Annual Permit to the Council within 48 hours of the receipt of the aforementioned notice.
- 44. (1) (i) A Permit Holder may at any time apply to the Council for an Annual Permit issued to them to be amended so as to relate to another vehicle provided that a maximum of two such amendments will be authorised in any twelve month period.
 - (ii) Upon receipt of an application pursuant to paragraph (1)(i) of this Article, and of the relevant Annual Permit, the Council may amend the Annual Permit accordingly or to such lesser extent as it thinks fit or, at its discretion, issue a revised Annual Permit, and if a revised Annual Permit is so issued, the original Annual Permit shall become invalid and shall (except in the case of an Annual Permit issued virtually) be surrendered to the Council.
 - (2) If an Annual Permit (other than an Annual Permit issued virtually) is lost, mutilated or defaced or the figures or particulars on it have become illegible or the colour of the Annual Permit has become altered by fading or otherwise, the Permit Holder shall (unless lost) surrender it to the Council and may apply to the Council for the issue to him of a duplicate permit and the Council, upon the receipt of the Annual Permit, if such receipt is accompanied by an application for a duplicate permit, shall issue a duplicate Annual Permit so marked.
 - (3) The provisions of this Order shall apply to a duplicate Annual Permit and an application for a duplicate Annual Permit as if it were an Annual permit or, as the case may be, an application therefor.
- 45. An Annual Permit ticket shall be in writing (unless issued virtually) and shall include the following particulars:-
 - (i) an authentication that the Annual Permit has been issued by the Council; and
 - (ii) the time and date on which, subject to the provisions of Article 43(4), the Annual permit expires.
- 46. At all times in which a vehicle is left in a Parking Place by or with the permission of a Permit Holder, there shall be displayed on the front of the vehicle the valid Annual Permit (except in the case of an Annual Permit issued virtually) issued in respect of that vehicle so that all the particulars referred to in Article 45 are readily visible from the front of the vehicle.

47. Where an Annual Permit has been displayed on a vehicle in accordance with the provisions of Article 46 no person, other than the Permit Holder, shall remove the Annual Permit from the vehicle unless authorised to do so by the Permit Holder.

PART V CONTRAVENTION OF ORDER

- 48. (1) If a vehicle is left in a Parking Place in contravention of any provision of this Order, a Penalty Charge shall be payable and/or the vehicle may be removed from that location.
 - (2) In the case of a vehicle in respect of which a Penalty Charge is payable, a Penalty Charge Notice showing the information required by any regulations made from time to time by the appropriate national authority pursuant to Part 6 of the 2004 Act may then be served by a Civil Enforcement Officer or by (or on behalf of) the Enforcement Authority in accordance with any such regulations.
 - (3) When a Penalty Charge Notice has been issued in accordance with the foregoing provisions of this Order, no person other than a Civil Enforcement Officer or a person authorised by the Council in that behalf or the Owner or Driver or a person authorised by the Owner or Driver in that behalf, shall remove the Penalty Charge Notice from the vehicle.
 - (4) Save as provided in paragraph (5) of this Article, where a Civil Enforcement Officer has removed or caused to be removed a vehicle in accordance with paragraph (1) of this Article:-
 - (a) he shall provide for the safe custody of the vehicle;
 - (b) the Enforcement Authority shall be entitled to recover from the person responsible such charges in respect of the removal, storage, and disposal of the vehicle as prescribed in any guidelines given by the appropriate national authority pursuant to Part 3 of Schedule 9 to the 2004 Act ;
 - (c) if it appears to the Enforcement Authority to have been abandoned, the Enforcement Authority may sell or otherwise dispose of the vehicle after having made reasonable enquiries to ascertain the name and address of the Owner of the vehicle provided that the Enforcement Authority shall be deemed to have made reasonable enquires to ascertain the name and address of the Owner of the vehicle if it has taken in relation to that vehicle such steps as may be prescribed by any regulations from time to time being in force by virtue of the Act for authorising the Enforcement Authority to sell or otherwise dispose of the vehicle had it been abandoned on a road.
 - (5) Nothing in paragraph (4) of this Article shall apply in respect of a vehicle displaying in the relevant position a valid Disabled Person's Badge issued by any Local Authority.
