Market Hall Museum enjoys a central location in the middle of Warwick's. In previous years we have seen footfall of over 1000 people in the museum each day for our craft/art events.

- Children's craft activity upstairs in the museum
- Mulled Wine and Mince pie stall outside the museum

The Victorian Fair will be promoted by Heritage and Culture Warwickshire (HCW) as a family event suitable for adults and children using our established marketing networks via printed advertising, press and social media. Staff and volunteers will be proactive in letting visitors know about the fair in the run up and will have flyers to give out.

All stallholders will be provided with a 6 foot table or equivalent space. Additional space will be limited to the area directly behind the stall ONLY. Tables will be located on the ground floor of the museum. Indoor and outdoor signage will direct visitors to your stalls.

All sale proceeds are your own, no commission taken.

Tables can be shared by more than one person.

#### **Terms and Conditions**

- Stalls at the Victorian Christmas Fair must be paid for before the
  event. Stalls cost £50. This fee is non refundable, except when Heritage and
  Culture Warwickshire (HCW) cancels the event.
- Entry to the fair is FREE for visitors.
- The hire of the space covers the period Thursday 24th November 12noon to 9pm inclusive. Stallholders must be present throughout. Please be ready to trade by 12noon and please do not stop trading until 9 pm.
- Stallholders are responsible for selling and handling money themselves; we cannot sell items for you. All transactions are between the Vendor and Purchaser alone. No responsibility will be accepted by Heritage and Culture Warwickshire for any transactions.
- Market Hall Museum is in a busy town centre location right at the heart of the Victorian Christmas Evening. Special unloading and parking restrictions apply in Warwick on the day. You will be notified about setting up times, parking and unloading details before the event.
- You will be provided with a table approximately 6" long. You will need to supply your own table covering. A table plan showing where your space is will be available upon arrival.
- Stallholders will ONLY have their table space and a limited space directly behind the stall. They must not take up any additional space that encroaches on neighbouring pitches or block access for visitors. Do not attempt to move museum fixtures or fittings to make extra space, or block access for visitors. You are not allowed to fix anything to the walls or exhibits of the museum. Please make sure there are no trip hazards and walk ways are not obstructed.

- We are looking for quality craft and items suitable for Christmas gifts.
   Stallholders are asked to respect the fact that we are a family venue when choosing appropriate items to sell. We reserve the right to refuse to allow certain items to be displayed if we do not think the subject matter is appropriate for a family venue. Additionally, we reserve the right to turn down bookings if we have too many stallholders selling similar items.
- Stallholders must dress in Victorian costume, we do not expect you to hire costumes but this is a stipulation for stallholders in the museum and on the street stalls. Please note, although the Fair will be held indoors, the museum doors remain open throughout the night so dress warmly.
- The space hired is suitable for selling items. We do not have space to allow stallholders to run workshops. Demonstrations are not allowed unless by prior arrangement. As we are a museum, no materials that could potentially damage our objects, or cause a health and safety risk to the public, are allowed in your space. This includes ink, paint, glue, hot water and sharp materials. Please do not bring materials such as, dried flowers, fresh flowers, twigs, teasels and other organic matter as it attracts pests and therefore cannot be allowed in the museum near our collections.
- The event will be marketed by HCW but we also ask that you help us promote
  it too. We will send you copies of flyers and you can also use the following

- If you bring a child or children with you, please note that they are your responsibility and should not be permitted to run freely around the Museum site.
- Stallholders will be given a discount voucher of 10% to be used in Market Hall Museum café, valid for the duration of the event. The museum shop will also have 10% off that night.
- The Museum will not be responsible for damage to stock or theft whilst on the premises.
- Your space is to be left tidy at the end of the event and any rubbish put in the bins.
- No responsibility will be accepted by Warwickshire County Council for the security of any goods, money or equipment before, during or after the event.
- Stallholders have a duty of care to ensure their own Health & Safety, and also that of members of the public. They are responsible for any and all damage or injury to persons or property caused by them or their stands or any act of omission by them or their staff.
