- Work closely with other colleagues to ensure a well-coordinated finance service is provided to the



Council.

- The provision of relevant services to other organisations where the Council provides such services.
- The provision of relevant services to the Warwickshire Pension Fund where the Council provides such services.
- Providing cover for senior finance officer treasury management activities to support the resilience of the service, for example banking, lending, and payments activity.
- Supporting project work in respect of the service, contributing to service/process improvements.
- Gathering and organising information to input into monitoring reports (financial reporting and management reporting).
- Reviewing the adequacy and appropriateness of service policies, practices, and procedures and ensuring appropriate documentation is kept.
- Supporting the development of new investment initiatives.
- Ensuring financial reporting has regard to appropriate accounting policies.

Assessing non-treasury investment bids and ensuring that the assessment practice remains fit for purpose.

Implementing approved investments and ensuring the appropriate processes are followed.

Monitoring and managing the investment and debt portfolios and reporting on performance.
