#### Role Purpose

Warwickshire County Council are investing in Children's Services and implementing exciting new ways to support children and families. Over the next 2 years we are investing in new projects which will extend early help support for families, integrate adult specialist practitioners into Children's Services, extend support to families in need of support and safeguarding and extend support for our children in care and care leavers. We are well on the road to good with a stable workforce, manageable caseloads and good supervision. However, we are ambitious and want to be the very best we can be for the children of Warwickshire.

We are looking for practitioners who value family. Who understand that family is sacrosanct- the most important part of children's lives and you must be willing to go the extra mile to take a whole family approach. Supporting parents and children to resolve issues as early as possible and support families to safely stay together.

This role as a Social Worker is within the Domestic Abuse Support Team. You will be working with the whole family in a restorative way to address domestic abuse, and support the family to improve their life chances or avoid issues escalating to Child Protection concerns. Social Workers will apply multi-disciplinary skills in their work with families, having a caseload specific to team area, depending on the identified level of need and demand on the service.

Responsibility for children and young people who are the subjects of Child in Need plans  
Attendance at meetings, including Child Protection conferences, strategy meetings and legal meetings.  
Preparation of court reports, statutory review and child protection reports.  
Participation in the duty system, including undertaking child protection investigations under appropriate supervision.  
Any other appropriate duties as and when required.

- To undertake a wide range of complex assessment of need/risk and devise support plans to meet identified outcomes, working in partnership with children, their families, agencies and other networks.
- Identify, source and review the support and services provided to ensure this continues to meet eligible needs and identified outcomes.
- To maintain and facilitate professional working relationships with partner agencies and others for the delivery of services.
- Take a key worker role in responding to safeguarding vulnerable children and families with managerial oversight for strategy meetings conferences and review, where appropriate.
- Ensure that all recording of social work activity is carried out in accordance with policy and procedures with due regard to data protection.
