WCC Parent / Carer Early Years & Childcare Survey 2021

We are currently running a Parent / Carer survey to help us to understand the early years and childcare needs in Warwickshire. It would be great to have as many responses as possible. The data we receive will be analysed to support our Childcare Sufficiency Assessment 2021.

Childcare Sufficiency Assessment (CSA)—Autumn 2021

We appreciate that the last 18 months have bought about lots of additional reporting and surveys that providers have had to complete, we greatly appreciate your support. To ensure we could meet the early years and childcare needs of families in Warwickshire we had to regularly review and monitor the effect the pandemic had on settings and the availability of places. As restrictions ease we will be moving to our annual CSA this term to monitor sufficiency of places. We hope that providers will find the CSA useful to support with place planning. Why do we need to complete a Childcare Sufficiency Assessment?

The Local Authority has a statutory duty to ensure that there is sufficient early years and childcare places for all families who need them in Warwickshire. To do this we must regularly monitor availability of places against demand using the CSA.

Early Education Funding—Staff Awareness

We have recently had calls from parents asking how to apply for the 3 & 4 year old universal entitlement. They say they have been told by their early years provider that they need to apply for a code. All 3 & 4 year olds are eligible for the universal entitlement (15 hours funding) the term after they turn 3. Parents do not need to apply for a code for this. Could we please ask that all staff are aware of the early education funding entitlements for 2, 3 & 4 year olds. Spending Review Outcome

Key announcements from the Spending Review for the early years and childcare sector:

- We are investing additional funding for the early years entitlements worth £160m in 2022-23, £180m in 2023-24 and £170m in 2024-25.
 This is for local authorities to increase hourly rates paid to childcare providers for the government's free childcare entitlement offers and reflects the costs of inflation and national living wage increases.
- £18 million in 2024-25 to create a network of family hubs to improve access to services for families, and £20 million in 2024-25 for parenting support.
- Over £200 million a year for the continuation of the holiday activities and food programme, providing enriching activities and healthy meals for disadvantaged children during school holidays.

<u>Pay Coronavirus Job Retention Scheme grants back</u>—Updated 29.10.21—Information updated because the Coronavirus Job Retention scheme ended on 30 September. Information added about when you must get a payment reference number and pay HMRC back.

<u>National professional qualification (NPQs): list of providers</u>—Updated 01.11.21— Updated the contact details for UCL Institute of Education: Centre for Educational Leadership under National provider, and added East Manchester Teaching School Hub to North-West providers.

Return to your claim for the Self-Employment Income Support Scheme—Updated 01.11.21—Section added with links to guidance for the fifth grant and previous grants. A link to guidance on how to pay back a grant has also been added.

COVID-19 Government Business Support Latest Updates continued

Tell HMRC and pay back a Self-Employment Income Support Scheme grant—Updated 01.11.21—If you've received a letter from HMRC you may need to pay back some or all of the grant. A new section has also been added called 'Check how to tell HMRC and pay money back'. You can use the service to check whether you need to tell HMRC and pay back a grant.

<u>Kickstart Scheme employer resources</u>—Updated 04.11.21—Added '5 tips to fill your Kickstart vacancy swiftly and successfully' document.

<u>National professional qualifications framework</u>—Published 05.11.21—Find out how to access national professional qualifications (NPQs) training and support for school teachers and leaders.

Check if you can claim back Statutory Sick Pay paid to employees due to coronavirus (COVID-19) - Updated 10.11.21—The state aid limits section has been updated since 1 January 2021 EU state aid rules no longer apply in the UK, except for aid in-scope of the Northern Ireland Protocol and Structural Funds.

<u>Kickstart Scheme closure</u>—Updated 19.11.21—Added deadlines for completing Kickstart Scheme tasks.

<u>Kickstart Scheme</u>—Updated 19.11.21—Employers and gateways must check the deadlines for the tasks they need to complete as part of the Kickstart Scheme.

<u>Kickstart Scheme terms and conditions</u>—Updated 22.11.21—Added new clause at the end of section 3 and added definition for 'project end date'.

<u>Claim a top-up refund or compensation for Childcare service issues</u>—Updated 25.11.21—'Claiming 30 hours free childcare compensation' section has been updated to clarify term dates and conditions for claiming.

<u>Early years funding</u>: 2021-2022—Updated 25.11.21—We've added the early years funded entitlement cost changes forecasts, England: spending round 2021 to 2022 document.

<u>Early years funding: 2022 to 2023</u>—Published 25.11.21—Information for local authorities and institutions about early years funding for the 2022 to 2023 financial year.

<u>Free courses for jobs</u>—Updated 26.11.21—Updated the information about adults who claim Universal Credit. Also updated the 'Free qualifications for adults' eligibility section to confirm that from April 2022, any adult in England earning under the National Living Wage will also be able to access these qualifications for free, regardless of their prior qualification level.

<u>Find a free level 3 qualification</u>—Updated 26.11.21—Updated 'List of free level 3 qualifications available to eligible adults'. New qualifications are highlighted by '(added November 2021)' in the qualification title field.
