⇒ **Estimate Deadlines**—Childminders **7th April 2022** and Nursery providers - **25th April 2022**

⇒ **Headcount Date** - **19th May 2022**.

⇒ **Headcount and Sufficiency Submission Deadline date** - **27th May 2022**.

⇒ **Payment dates:**

Childminder payments:

- Interim payments: 14th April 2022, 13th May 2022 and 15th June 2022
- Actual final payment: 15th July 2022

PVI's, Maintained Nursery Classes and Schools:

- Interim payments: 4th May 2022 - 3 & 4 year funding & 6th May 2022 - 2 year funding
- Actual Payments: 22nd June 2022 - 3 & 4 year funding & 24th June 2022 - 2 year funding

⇒ **Adjustments:**

- Adjustments tab opens - 13th June 2022
- Adjustments submission deadline - 8th July 2022
- Adjustments Payment date - 20th July 2022

30 Hour Codes for Summer term 2022:

- **ALL** new 30 hour codes for funding must have a start date by **31st March 2022** and an end date after **25th April 2022**. The Grace Period **does not** count for new codes.
- For continuing 30 hours funding, the 30 hour code must be within valid dates for the term or a Grace Period ending by at least 31st August 2022.
- The 30 hour code **dates** should be checked using the **Eligibility Checker** on the Provider Portal **BEFORE** offering a 30 hour place.
- 30 hour codes that had a **Grace Period ending on 31st March 2022** will **NOT** be accepted if re-confirmed on or after 1st April 2022.

If HMRC delayed the issue of a 30 hour code before 31st March 2022, we will consider funding the 30 hour code where evidence is sent to the Funding Office with the 30 hour code details showing that an application was made **before 31st March 2022**.
