The Important dates and deadlines for the remainder of this term can be found in the **Termly Information Letters** in brief:

Headcount Day: **6th October 2022**

Headcount Submission Deadline date: **14th October 2022**

Final Payment Dates: **3 & 4 year olds - 16th November 2022, 2 years olds - 18th November 2022**

Online Adjustment opening date: **7th November 2022**

Online Adjustments Submission Deadline date: **2nd December 2022**

Adjustments paid date: **14th December 2022**

**Note: Childminders are paid 15th monthly or the nearest working day.**

## Accepted 30 Hour Codes for Autumn term 2022

- **ALL** new 30 hour codes must have a start date **by 31st August 2022** and an end date **after 5th September 2022**. The Grace Period **does not** count for newly funded codes.
- For continuing 30 hours funding, the 30 hour code must be within valid dates for the term or a Grace Period ending by at least 31st December 2022.
- **BEFORE** offering a 30 hour place, the 30 hour code should be checked using the **Eligibility Checker** on the Provider Portal to **verify the dates**.
- 30 hour codes that had a **Grace Period ending on 31st August 2022** will **NOT** be accepted if re-confirmed on or after 1st September 2022.

We will consider funding a 30 hour code dated by 14th September 2022, where evidence is sent to us showing that an application was made to HMRC **before 31st August 2022**.

## EYPP and DAF

Applications for the Early Years Pupil Premium **EYPP** and the Disability Access Fund **DAF** are made by completing **Part 3** of the Parental Declaration Form **PDF**. Parents should be encouraged to enter their details if you believe that they may be eligible.

For EYPP you will receive up to and additional **£342 weighting per year** for an eligible child and **DAF £800 annually**.

## 2 Year Funding

Please help us to increase the take up of Childcare Funding for 2 Year Olds by letting parents know that they may be entitled. To check their eligibility and make an online application parents can go to our website [www.warwickshire.gov.uk/childcarecosts](http://www.warwickshire.gov.uk/childcarecosts). **Applications can only be authorised the term before the child is eligible. Applications for the Spring Term 2023 can only be processed now.**
