HOW WILL MY PLACE BE PAID FOR?

The funding will be paid directly to the childcare setting your child attends. These settings are all registered with Warwickshire County Council and Ofsted.

WHAT HAPPENS ONCE AN APPLICATION IS MADE?

Your application is checked for eligibility using the Government's Eligibility Checking System. If you are eligible a confirmation letter, detailing your EY Voucher Code, will be emailed or posted to you to confirm a funded place. You will also be sent a list of childcare settings in your area who offer funded 2 year old places. You will need to show your chosen setting your confirmation letter and give them your EY Voucher Code. If your eligibility cannot be confirmed you will be asked for supporting evidence.

Find out how you may be able to access a funded childcare place for your 2 year old

- up to 15 hours a week
- 38 weeks a year

You may be able to access a funded childcare place for your 2 year old if you are receiving one or more of the following benefits or credits:

- Income Support
- Income based Job Seekers Allowance
- Income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- > The Guarantee element of the State Pension Credit
- Child Tax Credit or Working Tax Credit, if your annual household income is less than £16,190
- Universal Credit if your annual net earned income is <u>less than</u> £15,400 OR
- >> The child is being looked after by the local authority
- > The child has left care through special guardianship or an adoption or child arrangement order
- > The child has a current statement of Special Educational Need, or an Education, Health and Care Plan
- >> The child qualifies for Disability Living Allowance

Additional extended criteria from September 2022:

- If your immigration status says you have 'no recourse to public funds', you may be able to access a funded childcare place for your 2 year old if you:
 - live in England and your annual household income is no more than:
 - £26.500 for families outside of London with one child
 - £30,600 for families outside of London with two or more children
 - have no more than £16,000 in savings or investments

Your childcare place will usually be for up to 15 hours a week, 38 weeks per year.

This could give you time to get help and advice, help you find out about your child's development and explore the learning and training opportunities available to you.

WHEN WILL MY CHILD BE ELIGIBLE?

Children usually have a place from the start of the school term after their 2nd birthday.

CHILDREN BORN BETWEEN:	FUNDED PLACES START FROM:
1st January - 31st March	Summer Term (from 1st April)
1st April - 31st August	Autumn Term (from 1st September)
1st September - 31st December	Spring Term (from 1st January)
