Autumn Term 2022 Headcount

The Headcount has been completed, we recommend that you check the Provider Portal to make sure that your Headcount is correct. **We are unable to accept any corrections after the term has ended.** Check that:

- All children are showing and with the **correct** hours .
- EYPP is showing where applied for, this is found under the **Weightings** column
- DAF has been accepted, this will show in the Adjustments section of the child and provider's **Summary** tabs.

Reminder - Online Adjustments Tab opens on 7th November

The Online Adjustments tab is open from **7th November 2022 to 2nd December 2022**. Please refer to the email sent on 2nd November 2022 for full details of the claim process. To enable us to accept your claim, a reason for the adjustment and a calculation of the hours claimed **MUST** be added. Guidance can be found at:

30 Hour Codes :

-  Check all 30 hour codes on the Provider Portal for codes that are now in their **Grace Period**, a yellow warning triangle will show next to the child's name. Remind parents to re-confirm their codes as soon as possible, especially if the **Grace Period is ending on 31st December 2022**.
- Check that continuing children have a Grace period that expires no earlier than **31st March 2023**
- Contact parents of **new children** starting 30 hours funding in the Spring term 2023 to remind them to apply for their 30 hour code at **now** and **no later than 31st December 2022**.
- Check that new 30 hour codes for Spring term 2023 have a start date **before** 31st December 2022 and an end date **after** 3rd January 2023. The Grace Period **does not** count for newly funded codes.
- Check 30 hour **code dates** using the **Eligibility Checker** on the Provider Portal to confirm they are eligible for funding in Spring term 2023. **DO NOT** rely on seeing a green tick.
