<u>Find examples to help you calculate your employees' wages</u>—Updated 8 April 2021—Examples updated to include employee reference dates.

<u>Calculate how much you can claim using the Coronavirus Job Retention</u>
<u>Scheme</u>—Updated 8 April 2021—Maximum wage tables and claim dates have been updated.
Updated 20 May 2021—Claims for furlough days in May 2021 must be made by 14 June 2021.

<u>Check which employees you can put on furlough to use the Coronavirus Job Retention Scheme</u>—Updated 8 April 2021—Section on employee transfers under TUPE and on a change in ownership has been updated. Updated 22 April 2021—Updated guidance for other types of employees you can claim for and if your employee is clinically vulnerable. Updated 20 May 2021—Claims for furlough days in May 2021 must be made by 14 June 2021.

Check if your employer can use the Coronavirus Job Retention Scheme—Updated 22 April 2021—Other types of eligible employees have been added to the 'Check if you're eligible' section. Updated guidance for when you're self-isolating or on sick leave. Updated 20 May 2021—Claims for furlough days in May 2021 must be made by 14 June 2021.

Steps to take before calculating your claim using the Coronavirus Jon Retention Scheme—Updated 8 April 2021—Section about employee reference dates added and changes made throughout the page to include employee reference dates. Updated 20 May 2021—Claims for furlough days in May 2021 must be made by 14 June 2021.

<u>Download a template if you're claiming for 100 or more employees through the Coronavirus Job Retention Scheme</u>—Updated 19 April 2021—The 'Check Your Data' tab for the Template XML and Template XMLS attachments have been updated.

<u>Penalties for not telling HMRC about Coronavirus Job Retention Scheme grant overpayments</u>—Updated 8 April 2021—Coronavirus Job Retention Scheme—receiving grants you were not entitled to (CC/FS48) has been updated.

<u>Claim a grant through the Self-Employment Income Support Scheme</u>—Updated 9 April 2021—This guidance has been updated with information about the fourth SEISS grant. Updated 21 April 2021—The online service for the fourth grant is now available.

Tell HMRC and pay the Self-Employment Income Support Scheme grant back—Updated 21 April 2021—New guidance on 'If amending your return affects your grant amount or eligibility' added under 'How to tell us' section. Updated 18 May 2021—New information added explaining when and how to tell HMRC about a tax return amendment if it affects your eligibility or grant amount. Links to more information on penalties and how HMRC can recover overpaid grants have also been added.

# COVID-19 Government Business Support Latest Updates continued

<u>Coronavirus (COVID-19): what to do if you're self-employed and getting less</u> <u>work or no work</u> - Updated 12 April 2021—Updated with the latest rates effective from 12 April 2021.

<u>Penalties for not telling HMRC about coronavirus (COVID-19) support scheme</u> <u>overpayments—CC/FS11a</u>— Updated 18 May 2021—Penalties information in CC/FS11a has been updated for the Self-Employment Income Support Scheme.

<u>Pay VAT deferred due to coronavirus (COVID-19)</u> - Updated 14 April 2021— Information has been added on penalties or interest that may be charged if you do not pay in full or make an arrangement to pay and how you may still be able to avoid these charges.

Local Restrictions Support Grants (LRSG), Restart Grant, Additional Restrictions
Grant (ARG): guidance for local authorities—Updated 19 April 2021—Additional Restrictions Grant (ARG): scheme definitions added for 'spend' and 'validated attempt'. Updated 4 May 2021—Payment deadlines have been extended for certain schemes.

<u>Test and Trace Support Payment Scheme privacy notice</u>—Updated 19 April 2021—Updated with correction: any payment made under the Test and Trace Payment Support Scheme is subject to tax, but not (as previously stated) National Insurance contributions.

<u>Test and Trace Support Payment scheme: claiming financial support</u>—Updated 12 May 2021—Updated attachment 'Claiming financial support under the Test and Trace Support Payment scheme' to make eligibility criteria clearer.

Help and support if your business is affected by coronavirus (COVID-19) - Updated 19 April 2021—A YouTube video about the Coronavirus (COVID-19) Job Retention Scheme and a webinar for Self-Employment Income Support Scheme (SEISS) - fourth grant have been added. Updated 29 April 2021—The YouTube video about the Coronavirus Statutory Sick Pay Rebate Scheme has been updated. Updated 10 May 2021—A catch up webinar for the Self-Employment Income Support Scheme—fourth grant has been added. Updated 19 May 2021—The recorded webinars for Self-Employment Income Support Scheme—fourth grant and Statutory Sick Pay (SSP) Rebate Scheme have been updated. <u>Coronavirus guidance for Companies House customers</u>—Updated 22 April 2021—You can use a same day service to electronically file a change of company name, or incorporate a company (software filing only). You must apply before 11 am. If you apply after 11 am, your application will not be processed until the next working day. We have suspended all other same day services until further notice.

<u>Apply for a Kickstart Scheme grant</u>—Updated 7 May 2021—Added that DWP may ask employers for their records to show how funding has been spent. Included information on how the funding is calculated for each young person. Also added that employers will receive an email telling them how to inform DWP about start dates or if someone leaves the job early.

<u>National Skills Fund</u>—Updated 10 May 2021—Added information about a temporary extension to the length of time people can undertake training to develop work-related skills and qualifications while still receiving Universal Credit.
