Welcome to Warwickshire County Council's Annual Parking Report

Warwickshire is a county rich in history and heritage and attracts many thousands of visitors each year. At Warwickshire County Council we strive to play our part in making Warwickshire a place where people choose to live, businesses want to invest and people like to visit.

Since November 2014 Warwickshire County Council has been responsible for the management of on-street parking. The Council's objective is to encourage safe and sensible parking and to create a pleasant and safe environment for all road users in Warwickshire.

We do this, in part, by providing an efficient and effective parking enforcement service.

It's recognised that, with almost 40 million vehicles licensed for use on the UK's roads, demand for parking space will be high, especially in areas where shoppers, residents, tourists and visitors are all competing for the same on-street space.

Everyone benefits from the operation of a successful, open and transparent approach to civil parking enforcement:

- Householders benefit from residents parking schemes, allowing them to park on street at or close to their homes for a minimal daily charge
- Increased turnover of parking spaces in town centres boosts shopping, tourism and trade
- Congestion on our road network is reduced
- Action can be taken against illegally parked vehicles, reducing inconsiderate or dangerous parking
- Road safety is improved
- Better access for emergency services and for people with disabilities
- The public has increased confidence in the fairness of the parking enforcement process



Aims and objectives

The parking management service at Warwickshire County Council seeks to follow the statutory guidance issued by the Secretary of State for Transport, which draws on the aims of the Traffic Management Act 2004.

A good enforcement regime is one that uses quality-based standards that the public understands, and which are enforced openly, fairly, accurately and without undue delay. This is consistent with current national best practice. Our approach provides clarity, consistency and transparency within the enforcement process.

It is a common misconception that schemes such as Civil Parking Enforcement are a means of making money for the local authority, and that Civil Enforcement Officers (CEOs) work to targets. This is not the case. CEOs have no targets.

Any surplus revenue that arises from parking management has to be accounted for and spent on a range of transport and environmental improvement purposes which further benefit the local area (see Financial reporting section).

With regard to parking, the stated requirement of the Traffic Management Act is for 100% compliance with waiting restrictions. The fulfilment of this aim will eliminate the need for penalty charge notices (PCNs) and improve the road environment for all users. At Warwickshire, through a process of enforcement, education and engineering, we seek to achieve 100% compliance with the parking restrictions in place. In this way, many of the benefits listed above will be delivered.

To assess compliance, we carry out reviews of on-street parking. In early 2017 a compliance report was produced, based on surveys over previous years.

The headline figures of this report show that, overall in Warwickshire, compliance with the parking restrictions has risen from an already high value of 86.7% in 2014 to 87.9% in 2015 and the same figure in 2017.

This high degree of compliance shows a welcome indication that the vast majority of motorists park legally and sensibly. Successful parking management provides a service which aims to help town centres thrive and residents to park at or close to their homes. We believe that this is something most motorists recognise and park accordingly.



NSL Ltd and Civil Enforcement Officers

The year 2017-18 represented the third full year of the contract between WCC and NSL Ltd.

Our parking enforcement service provider, NSL, directly employs the CEOs who are easily recognisable on-street by their green uniforms. Before taking up their duties they all receive extensive training in the relevant legislation and enforcement procedures, achieving the recognised City and Guilds qualification.

CEOs are trained to be professional and polite and will offer advice and guidance on where to park safely when asked. We expect our officers to be treated with courtesy and respect and will not hesitate to follow up any reported incidents of abuse or threatening behaviour. CEOs have body-worn cameras to record any such incidents.

CEOs are not able to rescind or take back a penalty charge notice (PCN). Once a PCN has been issued, the appeals process should be followed by anyone wishing to challenge it.

The appeals process

A motorist in receipt of a PCN has the right to appeal it. There is information on the reverse of each PCN on how to do this.

WCC parking management team adheres strictly to the statutory process for dealing with PCN appeals. **All appeals must be in writing.** We cannot enter into any telephone discussions about appeals.

In summary, the appeals process contains a three-stage approach as follows:

Stage 1 – informal challenge – appraisal carried out by NSL Limited, overseen, if necessary, by WCC

Stage 2 - formal representation - appraisal carried out by WCC

Stage 3 – independent adjudication – Traffic Penalty Tribunal

A motorist, therefore, has three opportunities to appeal during the lifetime of the PCN. We urge anyone who wishes to challenge their PCN to engage fully with the process, following the guidance provided in correspondence at each stage.

Ignoring a PCN does not make it disappear. It costs the Council money to run an effective parking management service and we aim to recover debts owed to us.

The decision made by The Traffic Penalty Tribunal is final and binding.

Warwickshire County Council is bound by the legislation which applies to civil parking enforcement (CPE) and on-street parking. In relation to the CPE budget, it is not the aim of the Council to generate income. The aspirations of CPE are, as stated above, to manage on-street parking to make Warwickshire a better place with particular regard to the matters mentioned in section 45(4) and section 122 of the Road Traffic Regulation Act 1984.

Within the framework of the relevant legislation, it is considered that civil parking enforcement should seek to be self-financing, as far as possible. However, it may be that the measures that are thought desirable to make Warwickshire a better place

generate an overall surplus beyond what is required to make CPE self-financing. That is permissible, provided any such surplus is then spent in certain ways described in section 55 of the 1984 Act. These ways include the ongoing administration of CPE itself, highways improvements, public transport schemes and environmental improvements.

Civil parking enforcement therefore provides a means by which an authority can effectively deliver wider transport strategies and objectives. Enforcement authorities should not view it in isolation or as a way of raising revenue. As shown in the figures above, WCC had a surplus in its parking account for the year of this report. That surplus was retained within Communities and Environmental Services budgets as is necessary to comply with section 55. All subsequent CPE surplus expenditure routes have directly benefited the people of Warwickshire.
