A Proposed New All-Through Free School

in Warwick District

Information for Academy Proposers

December 2021

Deadline for Applications: 5pm on Friday 18th March 2022

This document references and should be read in conjunction with 'The free school presumption: Departmental advice for local authorities and new school proposers (November 2019)'

Section A - Introduction

Under section 6A of the Education and Inspections Act 2006 (the 'free school presumption') where a local authority identifies the need to establish a new school it must, in the first instance, seek proposals to establish an academy.

Warwickshire County Council (WCC) has identified the need to establish a new All-Through School (4 to 16) in the South of Learnington/Warwick area with the secondary phase of the school to open in September 2023 (subject to works programme review). The authority is seeking proposals from appropriate sponsors to open this new school. Proposers should complete the accompanying Free School Presumption application form and return it to schoolorganisation@warwickshire.gov.uk by 5pm on Friday 18th March 2022.

Background/Context

Warwickshire is entering a period of significant growth, with large scale housing development proposed across the county over the next 15 years and beyond. As development progresses across the county there will be the need for the delivery of new provision during the next 5 years and effective planning for further new provision beyond that period.

There are approximately 125,200 children and young people aged 0-18 living in Warwickshire, this figure represents just over 1 in five residents (21%), slightly lower than the figure for England (22%). There are close to 87,000 pupils being educated in 247 state-funded schools in Warwickshire, of which 36 are mainstream secondary schools, 194 are mainstream primary schools, one is an all-through mainstream school, 10 are special schools and six are nursery schools. The current picture indicates that 87% of schools in Warwickshire are rated by Ofsted as good or better which means 88% of pupils in Warwickshire are being educated in a good or outstanding school. This compares favourably to a national figure of 85% of pupils with 87% of schools in England rated good or better by Ofsted.

The <u>Warwickshire Education Strategy</u> (2018-2023) sets out an overarching vision for education in Warwickshire. The main aim of the strategy is to improve educational outcomes, and therefore the life chances, of learners of all ages in Warwickshire.

Evidence of need

The new school will be located on the new Oakley Grove housing development. This development is part of the larger 4,500 home urban extension that is currently building out to the South of Learnington/ Warwick. The school will be required to provide education to pupils moving into the area as a result of this urban extension. The impact of all planned housing will not be met solely by expanding existing schools in in the area, and there is a need to ensure that pupil places are available as the new housing becomes occupied.

The new school will be located within the Warwick and Learnington Secondary Planning Area and the South Learnington Primary Planning Area, the latest pupil forecasts for these areas are shown below and demonstrate the need for the new provision.

Key Stage 2 2019 Results

66% of pupils in Warwickshire had met the expected standard at the end of Key Stage 2 in 2019, just above the national average for state funded schools in England of 65%. Warwick District was the highest performing of the five districts and boroughs with 68% of pupils at the end of key stage 2 in Warwick District schools achieving the expected standard in reading, writing and maths. In terms of progress, Warwickshire, on average, do about as well at key stage 2 as those with similar prior attainment nationally.

At Key Stage 4 Warwickshire students perform strongly in their GCSE and equivalent qualifications and above national comparator results.

Across the headline Key Stage measures, Warwickshire's pupils generally perform above the national average. However, the gaps between education outcomes for disadvantaged cohorts and their peers in Warwickshire are larger than national, and outcomes are lower than national for these groups. Therefore, in Warwickshire it is a priority that disadvantaged pupils continue to be given the extra support needed to achieve their potential.

Warwickshire vision for pupils with Special Educational Needs and Disabilities

In January 2021 there were 14,520 children with special education needs attending a school in Warwickshire, making up 16% of the school population. Of these, 3,353 (3.6%) had an EHCP and 11,167 (12%) were receiving lower level SEN support in school

In Warwickshire, all children and young people have the right to lead a fulfilling life and be part of their community. Every child and young person have a right to have their health, social care and education needs met within their local community. Every child has the right to attend a good local school that is appropriate for their level of need or disability, usually a mainstream school.

Every early years setting, state-funded school, further educational college and training provider will;

- Make good provision (as determined by Ofsted) for children and young people with SEND;
- ensure all pupils make good progress in their education and development;
- ensure that they transition smoothly into the next stage of their education and;
- as appropriate, they are helped to secure independent living and opportunities for employment.

The <u>Warwickshire SEND and Inclusion Strategy</u> sets out the vision for provision for SEND locally, across education, health and social care. The strategy has inclusion at its heart and sets out how Warwickshire plans to address imbalances and effect change across the SEND system. The strategy identifies six priorities:

- Promoting inclusion
- Getting it Right for Pupils with High Needs (school age)
- Improving Health and Social Care for SEND pupils
- Preparation for adulthood
- Transport
- Workforce development

Section B - The School

Site Location

The site secured to construct the new all-through school is located off Harbury Lane and Oakley Wood Road, Learnington Spa, with an approximate postcode of CV33 9QE

Section F - Funding and Costs

Ownership of the school land

Ownership of the school land is currently with the housing developer. The site is in the process of being transferred to Warwickshire County Council under the terms of the Section 106 agreement.

The County Council will provide the site and buildings on a 125 year lease to the Academy Trust (excluding the nursery accommodation).

Capital Costs

The capital cost to build the school will be met by Warwickshire County Council through a combination of developer funding contributions and Basic Need Funding.

The capital building scheme has already been designed and developed, with a construction budget of £49.5 million.

Revenue funding

Local authorities are also required to meet the revenue costs of the new provision. Warwickshire County Council will meet pre and post opening costs associated with establishing the new school, in line with the growth criteria agreed by Warwickshire Schools Forum. All proposed growth funding figures within this document are based upon the current criteria agreed by the local Schools Forum. Should there be any changes to this in the future prior to the signing of a funding agreement these figures will need to be revised. As part of the available start-up costs the DfE currently provides £25,000 for legal expenses to the successful sponsor. Further details of the pre-opening revenue funding is provided below, followed by details of post-opening revenue.

1. Pre-Opening Funding (Project Development Grant)

The pre-opening funding is intended to cover revenue costs up to the opening of the school. This can include project management, staff recruitment, salary costs and office and administration costs. The grant is paid in three instalments during the year prior to opening.

The current pre-opening funding grant follows a similar funding level to the project development grant given to new schools opened through the Central Government Free School Programme.

The new free school via the LA presumption route will be paid a pre-opening grant £275,000 (£175,000 if the trust is opening more than one school in an academic year).

An ICT grant will also be provided to fund the ICT equipment and expenditure not covered by the Capital Build.

The Trust will need to follow the conditions as part of the receipt of the Project Development Grant.

2. Post-Opening Funding

There are two elements to the post-opening grant: non-staffing resources paid on a per pupil basis and a leadership grant.

<u>The Resources element</u>: Paid each year that the school builds up to capacity for each new pupil expected to be on roll. It is paid at the following rates:

- £250 for each new mainstream pupil in the primary phase (R to 6)
- £500 for each new mainstream pupil in the secondary phase (7 to 11)

<u>The Leadership element:</u> Paid annually based on the number of year groups that the school will ultimately have that do not yet have pupils. The amount paid to mainstream schools depends on how many year groups are empty.

Pupil places in the specialist resourced provisions (SRP) are funded from the Dedicated Schools Grant (DSG) High Needs Block at a rate of \pounds 10,000 place funding per pupil plus top up funding of \pounds 8,415, so that a pupil's additional learning needs can be met. A service level agreement between WCC and the school will confirm the exact arrangements and expectations.

Section G - Impact and Equalities Assessments

As prescribed by section 9 of the Academies Act 2010 and section 149 of the Equality Act 2010, the local authority must assess the potential impact of any new school on existing educational provision in the area. The local authority must also consider whether the new school would impact on any groups with protected characteristics.

Pupil forecasts demonstrate that as a result of large scale housing development in South of Warwick/Learnington area additional primary and secondary provision will be required over the next 5 years and continue to be part of the provision of education in the area in the short, medium and long term. As a result, the addition of this school to the family of Warwickshire schools is unlikely to impact adversely on mainstream schools in the area.

The proposal would have a positive impact on promoting choice and diversity for local families who are applying for a school place. We are looking for sponsors that will provide excellent support facilities to meet the needs of all children, including Looked After Children, those with Special Educational Needs and Disabilities, those with pupil premium funding and any other disadvantaged group. We also want a sponsor that has a drive for excellent outcomes in attendance, attainment and achievement for all children and a clear commitment to closing the gaps between pupil groups, both within the school and against their national counterparts.

SECTION H - Application Process

Academy proposers wishing to express an interest in the new specialist school should do so by completing the application form available online. Only applications received by the published deadline of 5pm on Friday 18th March 2022 will be considered for evaluation.

Proposers must ensure that they are on the DfE's approved sponsor list. Any proposers submitting bids, who are not on the approved list, must contact the DfE before submitting an application. New proposers will need to be assessed by the department through the normal sponsor approval route. See the <u>department's sponsor approval process</u> for more information.

All applications received will be evaluated against the criteria set out in this specification and the key criteria set out by the DfE <u>here</u>.

Each criterion will be scored using the following 4-point scale:

0 = The evidence and argument contained in the application is 'inadequate'.

1 = The evidence and argument contained in the application is 'adequate'.

2 = The evidence and argument contained in the application is 'good'.

3 = The evidence and argument contained in the application is 'excellent'

Each section and criterion will be scored equally, no weighting applies.

Shortlisted applicants will be invited to an interview, with a panel arranged by Warwickshire County Council.

After the panel interview, Warwickshire County Council will send details of its preferred applicant, along with details of all bids, to the DfE for consideration.

The Regional School Commissioner (RSC) for the West Midlands, on behalf of the Secretary of State, will consider the local authority assessments and recommendations before deciding which proposer is in the best position to take forward the new school. The RSC will inform the local authority and the successful proposer of its decision, and the local authority will inform any unsuccessful proposers.
