2.	Minutes of the meeting held on 10 April 2025 and any matters arising	
	The minutes were agreed as an accurate account of the meeting.	
	There were no matters arising not covered by other agenda items.	

3. Opportunity for public participation

All members of the public present were welcomed.

Cllr Kettle followed up on the discussion at the last meeting about SD228. This has been pursued with Stratford District Council planning department and although some of the development is contrary to details of the granted planning application, more than four years has elapsed, and so little action can be taken. However, discussions continue.

- 4. Presentation from Grenergy on the proposed Battery Energy Storage System off Benton Green Lane Solihull, followed by a question-and-answer session. Jonathan Cooper, Senior Development Manager, and Norome Campanile, Project Developer at Grenergy Renewables.
 - Based in Madrid and were founded in 2007
 - Are present in 11 countries around the world and have over 70 renewable assets.
 - Entered the UK market in 2020, currently have 15 projects in development in the UK which equates to a pipeline of 1.5GW.
 - Currently building a 11GWh battery energy storage system in the Atacama Desert, Chile, which is one of the largest in the world.
 - The UK is facing an climate and energy security crisis
 - 1 Target to become net zero by 2030
 - 2 UK spends £250 million per month on importing electricity and has the highest electricity prices in Europe.
 - 3 Our electricity demand is expected to double by 2050
 - 4 The solution is renewable energy derived from natural resources that are constantly replenished such as wind and solar power.
 - 5 However, there are challenges with renewable energy such as it depends a lot on the weather i.e. the sun shining and the wind blowing, especially as the weather is becoming more unpredictable.
 - 6 Renewable energy lacks inertia which makes us more vulnerable to power cuts.
 - 7 When the grid is at capacity the government often switches of the wind turbines which adds up to millions of pounds of wasted energy.
 - Battery Energy Storage systems (BESS) are devices that enable renewable energy to be stored and used when demand is high. It can help stabilise the grid and can be used in emergency events to keep the lights on.
 - Currently have 4-5GW of BESS in the UK but it is anticipated by 2030 we will need 23-27GW

- The Benton Green Lane Site
 - 1 70MW capacity.
 - 2 132,000 volts.
 - 3 Approx 3ha in size.
 - 4 Will power 230,000 homes in a single hour.
 - 5 Will connect to the Berkswell main substation through underground high voltage cable under the public highway.
- Site enhancements proposed will double the mandatory biodiversity net gain and it will also include hedgerows and tree planting. Noise assessments will be carried out to make sure that sound is not above background noise level (500 metres away from the nearest residential property but 100 metres from a public right of way) regulations state you must be at least 30 metres away, no nighttime lighting in normal conditions. Will take 6-9 months to construct and there will be 1-2 visits per week for routine maintenance.
- New woodland area to the north and south of the site and there will be wildflower planting in between. Also proposed an attenuation pond with some wet grass.
- The one entrance that forks into two roads counts as two access as per fire safety guidance.
- Fire Safety as BESS sites use Lithium-Ion batteries.
 - 1 Internal battery management systems with emergency shutdowns.
 - 2 Heat, smoke and gas detection (alerts fire service).
 - 3 Aerosol based fire suppression system.
 - 4 Firewater will drain to basin so that no contaminated water leaches into the ground.
- Grenergy submitted a full planning application in June 2025, the application is available on the Solihull Borough Council planning portal where stakeholders can upload comments.
- Discussions: Smoke plume analysis indicates that smoke dissipates at 20 metres so is unlikely to impact residents or even potentially the scout group who operate in the fields nearby.
- It was pointed out that the photos in the PowerPoint presentation of Benton Green Lane make it appear far wider than it actually is.
- Anticipate getting water supply from fire hydrants if that is not possible then they will look at getting a water tank.
- The reason this project is being built on greenbelt land and not brownfield is the needed connectivity to the major substations which is found on the outskirts of cities which is where you will also find the greenbelts, it is less common to find a brownfield site. Also, for brownfield sites they would have to approach a landowner and ask them not to touch the land for 3-5 years while they get planning permission etc. while they could get a quick sell elsewhere.

5. Reports from the Warwickshire, Solihull, and Coventry Rights of Way Teams.

1) Warwickshire -

- The Countryside Access Management System (CAMS) is now live as of the 8 July, better allows to monitor customer contacts and allows the team to append legal documents. It's a mapbased system that will allow members of the public go in it will give you the route number and if you have an account, it will show you the issues you have highlighted and the case management.
- Allows mobile working so that rangers etc can raise queries, map assets, raise job work items while on the go.
- Will be exploring more functionality of the CAMS pro in the future.
- Maintenance carried out in the period Nuneaton and Bedworth group installed a ditch crossing a flight of steps on M359 in Fillongley on 10th April. Signposts installed on M463 at Wishaw on 1st May. The Coventry Ramblers also installed signposts on T41/T42 at Hurley on 24th April. The Rugby Ramblers cleared the R103 Path at Cosford on 13th May and they also cleared Bridleway R86 at Cathiron on 8th July.
- A new pedestrian gate was installed in Bishops Itchington SM85 in June 2025.
- A new 8m bridge was installed (SD180) in Langley in May
- The team are currently look at identifying structures (i.e. long bridges) on the rights of way network that need significant maintenance, putting a list together and have identified a source of funding for this financial year.
- Volunteers North: 8 days between 8th April and 8th July, South: 564 hours logged in the same period.
- DMMOs in the last 12 months 3 determinations have been reached (orders to be made) and 0 orders made.
- Diversion Orders: 32 applications received for Public Path Orders. In the Last 12 months 2 creation agreements have been made and 0 orders made.
- Team is not fully staffed at the moment due to two team members moving outside of the organisation.
- A concern was raised about a fallen over oak tree that was being held up by a wire fence near the allotment on W1651 and if it was on the council's radar.
- Shail to get back to the group about if there are two different queues for those applying for a planning application and those who require a diversion of a footpath to secure their planning application (would need to apply for a diversion order).
- Discussion was had around the use of formal letters and the use of volunteers.

2) Solihull -

- Impacts of schemes on Network: HS2: 13 PROWs affected with closures and diversions. Early work on the legal processes being undertaken on diversions, closures and signage.
 M42 Jct 5A: 8 PROWs affected with closures and diversions. Early work on the legal processes being undertaken on diversions, closures and signage.

3) Coventry -

- Have dealt with 4 planning applications since the last meeting, 2 are still live and relate to Park Hill Lane which is a byway open to all traffic alongside the A45, however there is a traffic regulation order restricting vehicle movement along large parts of the lane. An application has been put in to build 5 residential units. The Public Right of Way is currently being looked at and how to regularise its status, some comments have been submitted to the developers so are waiting for a response. 2nd development is also residential being put in alongside the A45 and crosses Park Hill Lane (proposing using a footpath that leads up to Park Hill Lane as access to the development). Coventry City Council has serious safety concerns of using the footpath as vehicular road access to the development both for the safety of the people in the existing residential properties and those accessing the footpath as visibility is poor etc. So an objection has been lodged for the 2nd application.
- Bridge on FP 250 repaired by rangers after a board had rotted through, the bridge was then vandalised, and the damage was so extensive that a completely new bridge was installed. The matter was reported to the police but no updates yet.
