Fund Update

2020/21 was expected to be dominated by: implementing the updated investment strategy following the 2019 valuation; pooling more funds into the Border to Coast Pension Partnership; and the uncertainty driven by Brexit and wider global economic tension. These were key issues for most of the year but were then superseded by the global pandemic from March.

The 2019 Valuation was successfully completed and revised strategies for funding and investment were approved in March 2020, these are included in the <u>Annual Report</u>. At a high level these show that the ratio of benefit promises to investment assets has improved. This, and the fact that the monthly benefit payments out are roughly equal to the monthly contributions in mean

that the Fund is on an even keel. Because of this, the investment strategy has been updated to gradually reduce exposure to volatile markets through public equities and increase exposure to 'income generating' assets like infrastructure.

In the 2015 Summer Budget, Government announced that Local Government Pension Schemes, like our Warwickshire Fund, should pool assets with each other to: save costs through economies of scale, improve governance, improve the approach to responsible investment, and improve access to infrastructure investments. Warwickshire is one of 11 funds within Border to Coast Pension Partnership, which won the Local Authority Pension Fund Awards "Pool of the Year" prize. A significant proportion of our assets are now in the pool following the transfer into Border to Coast's Sterling Investment Grade Credit Fund and continued commitments to each of the alternative investment funds: private equity, private debt, and infrastructure. Dialogue is still open on other funds which Border to Coast might create to help with investing our assets in line with our investment strategy.

Although COVID-19, Brexit and global trade disputes have caused financial uncertainty over the past 12 months, the Fund's long-term approach has fared well with our invested assets exceeding their target.

Looking to the future, the Fund has created a climate risk policy, which forms a part of the overall Responsible Investment policy which you can read in the Annual Report. Climate change is an area of increasing interest to the Fund, and we will be seeking to understand better the impact of the Fund on the environment, the Fund's exposure to risks driven by environmental change, and we will also be looking at the positive opportunities in this area as companies transition to a greener economy.

I would like to say a big thank you to the staff who work for the Fund who deliver the administration and investment functions. A significant amount of hard work has gone into delivering the 2019 valuation, the setting up of new funds with the Border to Coast Pension Partnership, maintaining adequate cashflow and most importantly continuing to make payments to pensioners in the current crisis.

Finally, it is with sadness that we report the death of Councillor Bob Stevens last July. Cllr. Stevens had been Chair of the Pension Fund Investment Sub-Committee for four years. His charm and humour will be missed. We are pleased to welcome Councillor John Horner as the new Chair of this Committee and look forward to the Fund continuing to develop in a sensible manner.

Pensions Increases 2021

This years 'Cost of Living' increase to pensioners is 0.5% which is payable from 12th April 2021. The full increase is only payable if your pension began on or before 27th April 2020.

If your pension began after this date a smaller increase will apply as shown in the table below.

The increase applies to the pensions of all widows, civil partners and children, those who retired on health grounds and all pensioners over the age of 55.

McCloud Judgement

You may have recently heard about a high court ruling regarding age discrimination in public sector pension schemes. In the Local Government Pension Scheme (LGPS), this relates to the transition of members from the Final Salary scheme to the new Career Average Revalued Earnings (CARE) scheme in 2014 and is known as the McCloud judgement.

What is the McCloud judgement?

The case concerns the transitional protections given to scheme members, in the judges and firefighters schemes, who in 2012 were within 10 years of their normal retirement age. Tapered protections were provided for those 3-4 years younger. On 20th December 2018 the Court of Appeal found that these protections were unlawful on the grounds of age discrimination. These findings apply to all public sector pension schemes.

Who is Affected in the LGPS?

Anyone who was an active member of the LGPS from 1st April 2012 and who have built up a pension in the scheme after 1st April 2014. This includes anyone who retired from the scheme after 1st April 2014 and is currently receiving their pension. If you retired before 1st April 2014 you will not be affected.

What will happen to my pension?

If you were a member of the scheme after 1st April 2014 we will compare the pension you would have been paid had you remained in the Final Salary scheme from 1st April 2014 up to your retirement date with the pension you were paid on retirement (which included CARE pension). This is called calculating the underpin. If your pension would have been higher had you stayed in the Final Salary scheme, your pension will be increased in line with the underpin calculation.



What are Warwickshire Pension Fund doing now?

In order to calculate the underpin, we are requesting information for all members affected by the McCloud case from our scheme employers. Specifically, we are asking for any change in hours or any breaks in service you may have had as these will be required to calculate the underpin.

This requires gathering data from over 190 employers. We aim to have this completed by December 2021.

What do I need to do?

At present, there is nothing you need to do. We will contact you if your pension is affected by the McCloud judgement. Please do not ask for any quotes from the team yet as we will not be able to respond until 2022.

Befriending calls are one-way libraries reach out



Warwickshire County Council's befriending calls and home library service have become an integral part of the wider package of support that the Council has offered to vulnerable residents since the start of the COVID-19 pandemic. For some, they have been a lifeline. In April last year, the Council's established 'home library service' started to make doorstep deliveries, enabling Warwickshire residents that were unable to access library services in any other way to have regular book deliveries to their homes and to keep reading.

Throughout the first lockdown and summer 2020, Warwickshire Libraries staff delivered books to hundreds of extra vulnerable and isolated customers who were shielding from COVID-19. Around 360 home library service customers across Warwickshire currently benefit from receiving a doorstep book delivery every 4 weeks, which equates to around 1,440 books being selected and delivered by libraries staff in the same period. Over 3,500 doorstep book deliveries have been made since April 2020

and the current lockdown means that many residents are, once again, reliant on the service as a way of coping with the restrictions that are needed to contain the virus.

In addition to the doorstep book deliveries, and as part of Warwickshire Libraries' offer to all residents who were shielding, a new 'befriending calls' service was set up in March last year. The service involves a friendly member of Warwickshire Libraries' staff phoning residents for a regular chat, to check how they are getting on and direct them to other services that may be able to help them - as well as to discuss the books that they have been reading and suggest other books that they might enjoy. One resident told libraries staff that she was "going down the pan" and that the befriending call she had received "brought her back up" and made her day.

A leaflet about the service was put in every box of food that was sent out by Warwickshire County Council's shielding hub to residents who were shielding from the virus last year.

Over 3,500 doorstep book deliveries have been made since April 2020

Staff who were answering telephone calls on the Council's shielding helpline could also refer any person that they thought would benefit from the befriending calls service, as well as anyone who asked about the service for themselves or other people. This meant that those receiving the calls weren't always existing Warwickshire Libraries customers or residents that had requested a library book delivery to their home.

As part of the conversation, library staff were therefore able to offer the home library service as an option and to tell people about how they could download eBooks and eAudiobooks online if they wanted to. Sometimes residents were referred to the library service's ICT and learning officers, so they could receive a telephone call to help them set up their tablets or laptops stepby-step, as part of Warwickshire Libraries' 'digital help' offer to shielding customers.

Library staff also contacted the Council's shielding hub if anyone they spoke to needed to have a food box delivered or to have medicines collected for them.

The restrictions saw an increased demand for the befriending calls, home library service and, since September, the contactless mobile library service. Now that Warwickshire and the rest of the country are back in lockdown, it is anticipated that more residents will be taking advantage of these important services.

Recipe:

Rocky Road



You can enjoy this rocky road which is quick to make and uses mainly store cupboard ingredients. This is an office favourite and something we have all missed since working from home!

Ingredients

(12 portions)

- 1.4kg milk chocolate,roughly chopped
- 8 regular-sized chewy,filled chocolatebars of of your choice(such as Snickers and Mars),roughly chopped
- 100g marshmallows
- 180g chocolate-coated malt honeycomb balls (such as Maltersers)
- 100g dried apricots,roughly chopped 100g raisins
- 100g cornflakes
- 100g chocolate vermicelli

Method

- 1. Grease and line a 33 x 23 x 5cm baking tray, lined with greaseproof paper.
- 2. Put the milk chocolate in a large saucepan over medium heat and heat until melted and smooth, stirring occasionally.
- 3. Put the chocolate bars, marshmallows, honeycomb balls, apricots, raisins and cornflakes in a large bowl and pour in the melted chocolate. Mix with a wooden spoon until everything is well mixed and the dry ingredients are evenly dispersed.
- **4.** Press the mixture into the prepared baking tray, using a tablespoon to flatten and compress it. Sprinkle the chocolate vermicelli all over the top. Leave to cool completely, then cover and refrigerate overnight.
