2025 Autumn Budget – Changes to salary sacrifice pension contributions

On the 26th of November the Chancellor announced a £2000 cap on pension salary sacrifice contributions. This will mean that employers and employees will have to pay national insurance contributions (NICs) on amounts over this limit.

It is important to note that main LGPS scheme contributions are not made under a salary sacrifice arrangement, this will only affect our members of the scheme who are making contributions over the value of £2000 per annum into an LGPS linked AVC salary sacrifice scheme.

In this context, salary sacrifice involves an employee giving up the right to part of their salary in return for higher pension contributions from their employer into an AVC. This is achieved by varying the employee's terms and conditions of employment.

Where salary sacrifice is used, both the employer and employee benefit from a reduction in their NICs. This is because an employee's salary is subject to employer and employee NICs, whereas employer pension contributions are not. Therefore, both employees and employers' benefit where salary is sacrificed in exchange for higher employer contributions.

The change will come into effect from April 2029. After the change, contributions made through salary sacrifice above the £2000 limit amount will be subject to employer and employee NICs, like other employee workplace pension contributions.

As more information on the changes becomes available, we will circulate with our employers.

Government consultation – Scheme improvement (access and protections)

The Ministry of housing communities and local government (MHCLG) has launched the LGPS: Scheme improvements (access and protections) consultation.

The consultation covers the following areas:

- Normal minimum pension age
- Pension access for councillors and mayors
- Academies in the LGPS
- New Fair Deal.

A draft set of regulations for the proposals on pension access for councillors and mayors, as well as new Fair Deal, have also been published for comment.

The LGPS and McCloud remedy webinar

These free webinars from Affinity Connect give Local Government Pension Scheme (LGPS) members an overview of the age discrimination remedy, known as the McCloud remedy.

These webinars will also help members understand how the LGPS works, what options they have as an LGPS member and give them the chance to ask any questions about the LGPS and the McCloud remedy.

The webinars are delivered by Affinity Connect, part of the Wealth at Work group.

It's likely that you're protected by the remedy if:

- you joined the LGPS or another public service pension scheme before 1 April 2012, and
- you had pensionable service between 1 April 2014 and 31 March 2022 (the remedy period), and
 - you were under age 65 for part or the whole of the remedy period, and
- you have not had a disqualifying gap – a gap of more than five years that ended after 31 March 2012 when you were not paying into the LGPS or any other public service pension scheme.
