Summary

The County Council is required to produce a Minerals and Waste Development Scheme (MWDS) under the Planning and Compulsory Purchase Act 2004. The Act requires local planning authorities to prepare a new series of planning documents which together make up a "Minerals and Waste Development Framework" (MWDF).

The MWDS is a critical part of the MWDF, giving an opportunity for the County to set out its current planning policies and to explain to the local community those plans and policies that it proposes to prepare over the next three years. The document covers the period 2007 – 2010. It identifies key milestones in the preparation of Mineral and Waste Development Documents, which will be project managed and subject to continuous review.

The first MWDS was submitted to the Secretary of State on the 24th March 2005, and following receipt of a non-intervention letter was brought into effect on the 9th June 2005. It was subsequently changed in November 2005, when the timetable for the preparation of the Waste Core Strategy was amended. The MWDS was amended for a second time changing the programme for the Minerals Core Strategy. It was brought into effect on the 28th November 2006.

Earlier this year, the Secretary of State wrote to all authorities anticipating that they would wish to amend their MWDS in light of the recent government guidance and the final Barker report. Accordingly, further amendments were approved by the County Councils Cabinet in February 2007. However, the approved revisions to the MWDS was not brought into effect, as the Environment Agency confirmed that a Strategic Flood Risk Assessment was needed prior to submission of the Core Strategy to the Secretary of State. A draft revised MWDS was therefore submitted to the Secretary of State (via Government Office for the West Midlands (GOWM) as 'work in progress' by the 1st April 2007 deadline. A holding direction was received on the 18th April 2007.

Following a series of meetings with Communities and Local Government (CLG), the Planning Inspectorate (PINs), and GOWM over the summer, a further revision to the MWDS has been approved by Members at Cabinet on the 15th November, amending the timetable again. These amendments and the revised timetable are the subject of this MWDS and will be explained in detail later.

To complete the picture, since bringing 'into effect' the first MWDS, Warwickshire County Council has produced the following documents during the period 2005 - 2007:

Therefore, the key priorities for Warwickshire County Council over the three year period 2007-2010 are as follows:-

Document	Comment
Waste Core Strategy	This will set a long term spatial vision, objectives and strategy for waste development across the County up to 2021, and provide the framework for waste development control.
Waste Allocations	If needed, this will provide detailed allocations
Development Plan Document (DPD)	for waste related development and criteria based policies where this is not possible.
Minerals Core Strategy	This will set a long term spatial vision, objectives and strategy for mineral development across the County up to 2021, and provide the framework for mineral development control. The Core Strategy will identify strategic sites and as a consequence it is not anticipated that the County will prepare a separate Minerals Allocations DPD.
Proposals Map	This will illustrate the policies set out in all development plan documents.

This MWDS explains how these documents will be prepared, including outlining when community and stakeholder involvement will be sought. It also explains what will be the role, relationship and status of other existing planning documents, including the County's saved policies (Warwickshire Structure Plan, Waste Local Plan and

Minerals Local Plan), the District's Development Documents and the Regional Spatial Strategy.

As identified above, the County's Statement of Community Involvement (SCI) is adopted, and whilst there are no plans at present to review this document. The County Council is aware that it may be amended as a result of the Government's White Paper 'Planning for a Sustainable Future' dated August 2007. Once more detail is published by Government on its proposals, the future and status of the SCI will be reviewed.

1. Introduction

- 1.1 This Minerals and Waste Development Scheme (MWDS) has been prepared to give the local community and all interested parties information on two important areas:-
 - What are the current mineral and waste planning policies that are being applied to Warwickshire County, and
 - What is the programme for reviewing these policies to provide updated policies for the County.
- 1.2 The County Council is required to produce a MWDS under the terms of the Planning and Compulsory Purchase (PCP) Act 2004. The legislation and accompanying regulations and guidance from Government give a framework within which the County Council must operate as it prepares this document. The MWDS identifies a three-year programme of work, and indicates in general terms what work is proposed beyond the three year period. It identifies key milestones in the preparation of mineral and waste development documents, which will be project managed and subject to continuous review. It must also be submitted to the Secretary of State, and should there be no objections raised by her within 28 days of submission, it comes into effect.
- 1.3 The first MWDS was submitted to the Secretary of State on the 24th March 2005, and following receipt of a non-intervention letter was brought into effect on the 9th June 2005. It was subsequently changed in November 2005, when the timetable for the preparation of the Waste Core Strategy was amended. The MWDS was amended for a second time changing the programme for the Minerals Core Strategy. It was brought into effect on the 28th November 2006.
- 1.4 Earlier this year, the Secretary of State wrote to all authorities anticipating that they would wish to amend their MWDS in light of the recent government guidance and the final Barker report. - 1.6 In producing this MWDS, the County Council is committed to the following:-
 - To make the Minerals and Waste Development Scheme as clear to understand as possible,
 - To publish the Minerals and Waste Development Scheme on the Council's web site (www.warwickshire.gov.uk/planning).

2. Relationship with existing Planning Policy Documents

- 2.1 This section provides an overview of the key planning documents that cover the County Council at the present time. In particular it gives guidance on the current state and status of documents prepared by the Regional Planning Body, as well as other planning authorities.
- 2.2 However, before setting the context, it is important to understand how the various documents relate to one another, and what their status is. This is particularly important given the recent changes in legislation, and the fact that the County Council has 'saved' planning policies prepared under the previous legislative framework. The key terms used within this Scheme are as follows:-

The Regional Spatial Strategy

2.3 The regional context for planning within the County is provided by the Regional Spatial Strategy. Regional Planning Guidance for the West Midlands was approved by Government in June 2004. With the commencement of the Planning and Compulsory Purchase Act 2004, it became the Regional Spatial Strategy for the West Midlands. As such it has statutory status. It therefore has development plan status and future LDD's will be required to be in general conformity with it.

In approving the RSS in June 2004, the Secretary of State identified a number of policy issues that needed to be addressed in future revisions to the document. The West Midlands Regional Assembly as the Regional Planning Body (RPB) agreed that the issues raised by the Secretary of State should be looked at in three phases:

 Phase One – The Black Country Study. The Black Country Study began three years ago when the Black Country's political and business leaders recognised the need to consider radical change in the sub-region to counter the process of decline of the last 30 years. The Study supports a sub-regional strategy for the Black Country, outlining the priorities for regenerating its physical, environmental, social and economic fabric. The West Midlands Regional Assembly, as Regional Planning Body, accepted the Study as a supporting document for the Draft RSS Phase One Revision, and it was submitted to Government on 31st May 2006. An Examination in Public commenced in June 2006, which was carried out by an Independent Panel appointed by the Secretary of State. Their report was published in March 2007, with the publication of the Secretary of State's proposed changes being published in September 2007. The final Phase One changes are expected to be published in early 2008.

- Phase Two Phase Two of the RSS Revision was launched in November 2005 and this is looking at housing figures, centres, employment land, centres, transport and waste. The Spatial Options were published in January 2007, and were subject to an 8 week period of consultation. This was followed by the development of the Preferred Option, which will be subject to formal consultation in January 2008. An Examination in Public is programmed for September 2008, with the final RSS Phase Two changes expected to be published in early 2009.
- Phase Three Phase Three of the RSS Revision will be looking at critical rural services, culture/recreational provision, various regionally significant environmental issues, minerals and the provision of a framework for Gypsy and Traveller sites. Preparatory work for Phase Three is underway and a Draft Project Plan was launched on the 27th November 2007. Consultation on the Draft Project Plan runs until the 17th January 2008.

Saved Policies

- 2.4 Provision under the 2004 PCP Act enabled those plans prepared under previous legislation to retain their previous status for a three year period after the commencement of the new Planning Act, i.e. until 27th September 2007. The Minerals and Waste Local Plans were 'saved' for three years. The County Council put forward a case to the Secretary of State by the deadline of the 31st April 2007, to save certain policies beyond the three year 'saved' period. These saved policies will be progressively replaced by DPDs within the MWDF. The 'saved' policies that affect the County are as follows:-
- 2.5 The **Warwickshire Structure Plan** was adopted in 2001 and was "saved" until 27th September 2007. Certain policies were sought to be saved beyond this period, and the Direction from the Secretary of State issued on the 7th September 2007 saved the following policies:-
 - Policy GD7 Previously Developed Sites,
 - Policy I2 Industrial Land Provision.
 - Policy T7 Public Transport

- Policy T10 Developer Contributions, and
- Policy TC2 Hierarchy of Town Centres.

The reasons for saving the policies are outlined in Appendix 5.

- 2.6 The **Minerals Local Plan** for Warwickshire was adopted by Warwickshire County Council in 1995, and was 'saved' until 27th September 2007. Certain policies were sought to be saved beyond this period, and the Direction from the Secretary of State issued on the 7th September 2007 saved the following policies:-
 - Policy M1 Areas of Search and Preferred Areas,
 - Policy M4 Sand and Gravel Extraction in the Context of Landbanks,
 - Policy M5 Sterilisation of Mineral Reserves,
 - Policy M6 Considerations and Constraints affecting Minerals Extraction,
 - Policy M7 Mitigation and Planning Conditions/Agreements,
 - Policy M9 Restoration of Mineral Workings and
 - Policy M10 -Monitoring of Mineral Sites.

The reasons for saving the policies are outlined in Appendix 6. The saved policies will be progressively replaced by LDDs which will have the status of Development Plan Documents

- 2.7 The **Waste Local Plan** for Warwickshire was adopted by the County Council in 1999, and was 'saved' until 27th September 2007. Certain policies were sought to be saved beyond this period, and the Direction from the Secretary of State issued on the 7th September 2007 saved the following policies:-
 - Policy 1 General Land Use,
 - Policy 3 Landfilling,
 - Policy 5 Incinerators,
 - Policy 6 Material Recycling Facilities,
 - Policy 9 Large Scale Composting and
 - Policy 13 Proposed Facilities.

The reasons for saving the policies are outlined in Appendix 7. The saved policies will be progressively replaced by LDDs which will have the status of Development Plan Documents.

3.0 Proposed Local Development Documents

3.1 This section of the MWDS considers in more detail the LDDs that the Council proposes to prepare, and the key priorities for Warwickshire County Council over the three year period 2007-2010 are as follows:-

	The County Council will work with the District and Borough Councils, who will be required to include on their adopted proposals maps safeguarded areas, mineral consultation areas and any adopted minerals and waste allocations.								

- 3.2 In line with advice from CLG where both Minerals and Waste DPDs need to be prepared (which is the case in Warwickshire), the MWDS identifies that priority will be given to the Waste DPD. This reflects the need for up-to-date waste plans to support the delivery of the Government's national waste strategy and the contribution this makes to meeting EU obligations.
- 3.3 The reason why the MWDS amended in February 2007 could not be brought into effect, was due to the uncertainty about the need to undertake a SFRA, as required by Planning Policy Statement 25 (PPS25) Development and Flood Risk at the Core Strategy stage. Clarification sought from the Environment Agency, CLG and GOWM who confirmed that this does need to be in place as a part of the evidence base prior to submission of the Core Strategy for independent examination. The County Council, together with the Warwickshire Districts, Coventry City Council and Solihull Metropolitan Council

have therefore commissioned consultants to undertake this work jointly. The Level 1 SFRA should be complete by the end of December 2007.

- 3.4 Whilst this SFRA has been undertaken by consultants, two County Council's having both submitted Core Strategies to the SoS for examination, were advised by the PINs that should they proceed to examination, their Core Strategies were likely to be found "unsound". This advice appeared to be based on 'emerging guidance' that that core strategies should to be "allocating strategic sites and areas critical to the delivery of the strategy's vision" and making the difficult decisions in the Core Strategy.
- 3.5 Therefore, against this background over the summer, we have reviewed and questioned the approach that has, hitherto, been taken to the preparation of its waste core strategy. Advice has been sought from CLG, PINs and GOWM in order to avoid producing an 'unsound' core strategy. It is understood from colleagues around the country that the issue is a national problem with several other County Council's finding themselves in a similar position. National meetings have taken place with CLG, PINs and county waste authorities to resolve the issues emerging in relation to the identification of strategic sites and to find an agreed way forward.
- 3.6 Following detailed discussions with GOWM, it is considered that the Council's Waste Core Strategy needs to be taken back to the Options stage (i.e. two stages back in the process). It is therefore proposed to consult on a range of spatial options to deliver the waste strategy. After the adoption of the Core Strategy it is still the intention to prepare a Site Allocations Development Plan Document.
- 3.7 In relation to the Minerals Core Strategy, it is considered that, in order to deliver the strategy in Warwickshire, it will necessitate the identification of strategic sites at the Core Strategy stage, in line with emerging guidance. Therefore, it is proposed to produce a Core Strategy only, which will identify strategic sites. This is a major change in direction and will require a lot more detailed evidence and site information to be in place by the time the Core Strategy is submitted for Examination. The revised timetable for the preparation of the Core Strategy reflects this.

The Evidence base of the Minerals and Waste Development Framework

3.8 The main sources of data that are relevant to the preparation of the Minerals and Waste Development Documents are as follows: -

Internal to the County Council

- Minerals landbanks and planning permissions
- Landfill capacities and capacities for treatments of waste and waste planning permissions

- Environmental records designated areas for protection of nature and historic interest
- Transport
- Public rights of way
- Habitat Regulations Assessment of the EU Habitat site at Ensor's Pool in Nuneaton

External

- SFRA The Environment Agency have confirmed that this needs to be complete prior to submission of the Waste Core Strategy. Consultants have been appointed to conduct a level 1 study for both minerals and waste. Consultants will also be required for a level 2 study of strategic mineral sites, and may be required for waste facilities.
- Water resources, pollution control, contaminated land and waste arisings
- Pollution control
- Minerals resource mapping and safeguarding areas
- Mining hazards
- Protected species

Sustainability Appraisal

3.9 The County Council must comply with the European Union Directive 2001/42/EC, which requires a strategic environmental assessment of certain plans and programmes. The Directive will apply to all Development Plan Documents, and as such a Sustainability Appraisal (SA) has been produced to date and will continue to be produced as required for each.

Annual Monitoring Report

- 3.10 The Council is required to monitor annually the effectiveness of the policies contained within its LDDs. For the purposes of this report, the Council will be monitoring the policies of both the Waste and Minerals Development Documents and is required to produce an Annual Monitoring Report (AMR) The report will be prepared annually and will be published online, at www.warwickshire.gov.uk/amr, by the County Council by 31st December each year. It will be made available on request.
- 3.11 This report will assess the following aspects as to the progress of the two plans:-
 - Meeting the targets set in Minerals and Waste Development Documents, and the achievement of the key milestones.
 - Assess the impact that the policies are having on other targets set at national, regional and local level,
 - Progress in achieving milestones in the preparation of Mineral and Waste Development Documents as defined in the Local Development Scheme.
 - Identify any policies that need to be considered for early review to meet sustainable development objectives.
 - Actions to be taken if policies are to be reviewed.

4 Supporting Statement

Political Management of the Minerals and Waste Development Framework

4.1 The Local Authorities (Functions and Responsibilities) (Amendment) (No. 2) (England) Regulations 2004 outlines the arrangements to be put in place to allow effective decision making by the Council. The County Council's constitution therefore identifies that approval of Local Development Documents are made by the following committees.

Delivering the Minerals and Waste Development Scheme – What could go wrong?

- 4.2 There will always be a level of uncertainty associated with a document such as this Minerals and Waste Development Scheme. It is legitimate to ask how reasonable and achievable are the targets set out above, and what issues may affect the overall delivery of the MWDS.
- 4.3 As part of preparing this MWDS, the County Council has carried out a Risk Assessment of the projects contained in this document, and has identified a number of areas of risk.
 - Level of public engagement. An assumption has been made of the amount of time that will need to be allocated to public and stakeholder involvement. Whilst this has been based on past experience, it cannot accurately predict how many people will wish to engage with the council on a particular project.
 - 2. Changes in government legislation and regulations. This MWDS has been based on the most up-to-date Government guidance. In view of the

legislative changes that are taking place, guidance is currently being drafted, and further guidance, there may be impact upon processes and targets.

- 3. **Staff turnover**. There is a degree of flexibility within the MWDS to allow for staff to be re-deployed to meet key targets.
- 4. Additional unforeseen pressures on staff time. These can never be predicted in advance, however the Council is committed to making available the resources, where it is possible, to plug any gaps brought about by such unforeseen pressures.


