Car 	No vouchers required
Car and trailer Up to 1.83m (6 feet) in length 	No vouchers required
Van or pickup 	Eligible to apply for 6 vouchers/year
Caravanettes, peoples carriers and minibuses 	No vouchers required if seats are not removed – otherwise 4 vouchers/year
Twin cab pick-up or large 4x4 	Eligible to apply for 4 vouchers/year
Commercial vehicle Over 2.2 tonnes 	Not permitted
Van and trailer 	Not permitted
Pick-up and trailer 	Not permitted

This Scheme applies to anyone who uses

- a van
- a commercial type vehicle; or
- a pick-up or large 4x4



### Vouchers for small vans

Vouchers to use the Recycling Centres are available FREE of charge for Warwickshire residents, whose only means of transport is a car-derived van or pick-up with a gross vehicle weight of up to 2.2 tonnes (this information can usually be found on the VCS vehicle registration document).

Successful applicants will be granted six vouchers – entitling you to deliver household waste in your vehicle up to six times a year.

You will not be eligible for vouchers if you or other members of your household have access to a car in addition to a van or pick-up.

### Vouchers for twin cab pick-ups

If your household's only vehicle is a twin cab pick-up, you may qualify for four vouchers a year.

You will not be eligible for vouchers if you or other members of your household have access to a car in addition to a twin cab pick-up.

### Terms and Conditions

- Vouchers will not be issued for transit type vehicles or any vehicle which has a legal gross weight of over 3.5 tonnes;
- Vouchers will not be issued for hired or borrowed vans;
- Vehicle vouchers do not allow you to dispose of commercial (trade) waste;
- The issuing of vouchers does not allow unlimited quantities of waste to be deposited at household waste recycling centres;
- Trailers will not be accepted on any vehicle which qualifies for a permit or voucher.
