Accepting the school place offered

Your school place will automatically be accepted

You are required to notify Warwickshire's Admissions Service if you do not intend to accept the place offered. You will be required to provide a reason for declining the place offered, which must be a suitable alternative education provision.

Declining the school place offered

If, for any reason, your child does not require the place that has been offered, please tell us as soon as possible. The place can then be re-offered to another child. If you have been offered an alternative school, it is important that you tell us, as the Admissions Service has a duty to track the future school destination of <u>all applicants</u>.

Declining a school place has no impact on the outcome of a higher preference. It is advisable to accept the school place which has been offered until you have secured a place at a school which you would prefer.

Waiting Lists for Warwickshire Schools

Your child will automatically be placed onto the waiting lists for those Warwickshire Schools listed as a higher preference than the school offered. Contact the Admissions Service if you wish to change your preferences or be added to additional waiting lists.

Waiting lists are held in over-subscription criteria order and a child's position is subject to change. Children can move up or down the list and applicants previously considered as late are not penalised on waiting lists.

If a space becomes available at a school, the parent/carer of the child at the top of the waiting list will be contacted. Re-offers will commence from **Monday 08 May**, as part of three specifically dated reallocation rounds.

Waiting lists for Community and Voluntary Controlled Schools will be held until the end of the Autumn Term. Some Academies and other own admission authority schools also adopt the Local Authority's policies. You can find out about an individual school's admission arrangements by looking at their admissions procedure for 2017 entry. This can be found on the school's website or you can contact the school directly for further information.

School Appeals for Warwickshire Schools

You have the right to appeal for any school where your child has been refused a place. You may wish to wait for the outcome of re-offers, from 18 April 2017, before lodging an appeal.

Lodging an Appeal

If you wish to appeal please complete the online appeal form which can be found at: www.warwickshire.gov.uk/schoolappeals

If you wish to complete a paper appeal form please contact the Admissions Service. It is important that you read the guidance enclosed with the appeal form before completing your appeal.

You must set out the grounds for your appeal in writing at the time of submission.

Appeals should be submitted by the deadline of <u>Monday 22 May 2017</u>. Appeals lodged by this date will be heard by 21 July 2017. Any appeals submitted after 22 May will be heard within 30 school days from the date the appeal is submitted. This means that appeals submitted after 09 June may not be heard until the new academic year in September 2017.

All appeal forms will be acknowledged within 5 school days.

Your offer letter informs you of which oversubscription criteria apply to your child. If the criteria section is blank, the school you have applied for is either; outside of Warwickshire, or is an own admission authority school who apply their own criteria.

Free Transport

If your child qualifies for <u>free transport</u> then you should <u>apply now</u>. Applications must be submitted by the deadline of <u>Friday 26 May 2017</u> to ensure that your bus pass is available in time for the start of the academic year in September. We are unable to guarantee that applications for free transport received after this date will be processed in time for the start of the Autumn term.

Vacant Seats Scheme

If your child does not qualify for free transport then you can still make an application for a paid bus pass. Further details about this scheme can be found on the website.



Vacant Seat applications can be submitted from 05 June 2017, and must be submitted by the deadline of <u>Friday 21 July 2017</u>. We are unable to guarantee that applications for Vacant Seat applications received after this date will be processed in time for the start of term in September.

If your application is late and cannot be processed before the start of term in September, or we cannot offer you a Vacant Seat, then you will need to make alternative arrangements until we are able to allocate you a seat.
