

What to do next

Accepting the place offered

We highly recommend that you accept the school place which has been offered to your child at this stage, even if it is not your first choice school.

You can accept your school offer in either of the following ways, but please only choose one:

- Log into your **online account** through the Warwickshire Parent Portal and accept the offered school by following the on-screen instructions on your child's application page, or;
- **Email** the Admissions Service's using the dedicated email address outlined below to confirm your acceptance of the school offered:

You must include your child's full name, their date of birth, their home address, your name and relationship to the child, and which school has been offered and being accepted in your email.

Declining the place offered

If you do not wish to accept the school place which has been offered to your child then you should have alternative provision in place for September 2018. This could include a confirmed place at an independent (private) school, or that you have made the decision to home educate your child. You should also notify the Admissions Service if you have decided to delay your child starting school until they are 5 years old. **This must also be in agreement with the school which your child has been offered.**

The Admissions Service may not action the request to decline the school place offered if alternative provision has not been secured. The offer may then either be automatically accepted on your behalf or, alternatively, the offer may be withdrawn from you completely and your child will be left with no school place to start in September.

If your child does not attend the school allocated, at the start of term in September 2018, then the school and/or the Admissions Service may identify your child to the Children Missing in Education (CME) and/or the Attendance, Compliance and Enforcement (ACE) teams, who have the authority to begin legal proceedings in relation to children who are not attending school, where this is required. It is therefore very important that you make the Admissions Service aware of your child's education destination for September 2018 entry.

Waiting Lists for Warwickshire Schools

If your child has not been offered a place at one or more of your preferred schools this is because there were more applications received for those schools than there were places available. When this happens, applicants are ranked in the order of the over-subscription criteria, as determined by the admission authority of the school concerned. Places are then offered to those applicants who have been allocated the highest criteria until all available places at the school are filled.

Your child will automatically be added to the waiting list(s) of any school(s) listed as a higher preference than the school offered, as outlined on your application. The waiting lists will include both on time and late applications, so your child's position on any of those lists could change at

any time. Applicants can move both up and down on the waiting lists and new (late) applications can be received – and will be processed - for any school until the coordinated admissions process ends on 31 August 2018.

If you have been refused a place at a school which is maintained by a different Local Authority than Warwickshire, then you will need to contact that authority directly for information on why it has not been possible to offer a place to your child and to determine your child's position on the waiting list for the school concerned.

Waiting lists, for September 2018 entry, for all Warwickshire schools will be held until December 2018, at which time all of these lists will be discarded.

Please see the section titled 'Reallocation rounds' in your main offer letter.

School Appeals for Warwickshire Schools

You have the right to appeal for any school where your child has been refused a place. You may wish to wait for the outcome of re-offers, from 14 May 2018, before lodging an appeal.

If you wish to appeal for a Warwickshire school please complete the online appeal form which can be found at: **www.warwickshire.gov.uk/schoolappeals**

You should set out the grounds for your appeal in writing at the time of lodging your appeal. You can also submit additional information in line with the scheduled hearing dates as set by Legal Services, who will organise your appeal hearing. All appeals will be acknowledged within 5 school days.

Appeals should be submitted by the deadline of **14 May 2018**. Appeals lodged by this date will be heard by 20 July 2018. Any appeals submitted after 14 May will be heard by 20 July where possible, or within 30 school days. The deadline for submitting an appeal to be heard before the start of the new term in September is Thursday 28 June 2018. It may not be possible to hear appeals received after this date prior the start of term. Please note no appeals will be heard between 31 July 2018 and 20 September 2018.

If you wish to appeal for a school in another local authority then you should contact the school directly for further information about their appeal process.

****You can only lodge one appeal for each school for each academic year of entry****

Free Transport

If your child qualifies for free transport then you should apply now. Applications must be submitted by the deadline of **Friday 25 May 2018** to ensure that your bus pass is available in time for the start of the academic year in September. We are unable to guarantee that applications for free transport received after this date will be processed in time for the start of the Autumn term.

Vacant Seats Scheme

If your child does not qualify for free transport then you can still make an application for a paid bus pass. Further details about this scheme can be found on the website.

Vacant Seat applications can be submitted from 04 June 2018, and must be submitted by the deadline of **Friday 13 July 2018**. We are unable to guarantee that applications for Vacant Seat applications received after this date will be processed in time for the start of term in September.

If your application is late and cannot be processed before the start of term in September, or we cannot offer you a Vacant Seat, then you will need to make alternative arrangements until we are able to allocate you a seat.
