## **ROAD TRAFFIC REGULATION ACT 1984**

## THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, CLIFTON UPON DUNSMORE, RUGBY) (30 & 40 MPH SPEED LIMIT) ORDER 2016

The Warwickshire County Council, in exercise of its powers under sections 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

- 1. Save as provided in Article 3, no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road described in Schedule 1 to this Order.
- 2. Save as provided in Article 3, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road described in Schedule 2 to this Order.
- 3. The provisions of Articles 1 and 2 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
- 4. In 'The Warwickshire County Council (Clifton upon Dunsmore Parish and Newton and Biggin Parish, Rugby) (30 mph, 40 mph and 50 mph Speed Limit) Order 2015' Schedules 2 and 3 thereof are hereby revoked in its entirety.
- In 'The Warwickshire County Council (Newton Road, Clifton upon Dunsmore / Newton and Biggin) (30 and 50 mph Speed Limit) Order 2015' Schedule 1 thereof is hereby revoked in its entirety.
- This Order may be cited as "The Warwickshire County Council (Various Roads, Clifton upon Dunsmore, Rugby) (30 & 40 mph Speed Limit) Order 2016" and shall come into operation on the Twenty-Sixth day of September Two Thousand and Sixteen.

# SCHEDULE 1

## (30 mph speed limit)

- <u>Hillmorton Lane, Clifton upon Dunsmore</u> From a point 553 metres north of the junction between The Kent and Lower Hillmorton Road, in a southerly direction to its merge with The Kent
- 2. <u>Lilbourne Road, Clifton upon Dunsmore</u> From a point 82 metres east of its junction with Hillmorton Lane (central splitter) in an easterly direction for a distance of 450 metres
- <u>Newton Road, Clifton upon Dunsmore</u> From a point 55 metres north of its junction with North Road/Church Street/Manor Lane, in a northerly direction for a distance of 160 metres.

## SCHEDULE 2 (40 mph speed limit)

1. Hillmorton Lane, Clifton upon Dunsmore

From a point 92 metres south of its junction with South Road in a southerly direction to a point 553 metres north of the junction between The Kent and Lower Hillmorton Road

2. Lilbourne Road, Clifton upon Dunsmore

From a point 532 metres east of Hillmorton Lane (central spiltter) in an easterly direction to its junction with A5, Watling Street for its entire length.
