THE WARWICKSHIRE COUNTY COUNCIL (LINK ROAD NORTH, RUGBY) (30 & 50 MPH SPEED LIMIT) (VARIATION NO. 1) ORDER 2020

The Warwickshire County Council in exercise of its powers under section 84 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

- 1. The Warwickshire County Council (Link Road North, Rugby) (30 & 50 mph Speed Limit) Order 2019 (which said Order of 2019 is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Schedule 1 to the Principal Order, delete <u>Link Road North</u> entirely, and replace with:-

"Houlton Way (Link Road North)

- (i) From a point which commences in line with the back of footway of the south-eastern side of Clifton Road, extending in a generally south-easterly direction along Houlton Way for a distance of 489 metres.
- (ii) From the north/south centreline of Hillmorton Lane, in a north-westerly direction for a distance of 90 metres.
- (iii) From the north/south centreline of Hillmorton Lane, in a south-easterly direction for a distance of 90 metres."
- 3. In Schedule 2 to the Principal Order, delete <u>Link Road North</u> entirely, and replace with:-

"Houlton Way (Link Road North)

- (i) From a point which commences 489 metres south–east from the back of footway on the south-eastern side of Clifton Road, generally southeastwards to a point 90 metres north-west of the north/south centreline of Hillmorton Lane.
- (ii) From a point 90 metres south-east of the north/south centreline of Hilmorton Lane, south-eastwards for a distance of 850 metres."

4. This Order may be cited as "The Warwickshire County Council (Link Road North, Rugby) (30 & 50 mph Speed Limit) (Variation No. 1) Order 2020" and shall come into operation on the 14th day of December Two thousand and twenty.
