1. Background

It has been requested by a number of residents to provide a residents parking scheme for Radford Road. Due to the nature of this road these bays need to be located on the footway

Owing to an administrative error it is necessary to revoke the following two orders and readvertise the restrictions.

- The Warwickshire County Council (District of Warwick) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) Variation No. 4 Order 2019
- The Warwickshire County Council (District of Warwick) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) Variation No. 5 Order 2020

The proposals that are being readvertised are listed as **Tavistock Street** and **Valley Road**, **Crown way and Mason Avenue**

2. Statement of Reasons

Radford Road – Footway parking except permit holders L7

It is proposed to provide short sections of footway parking along Radford Road available for vehicles displaying a valid L7 permit. This will aid in preserving or improving the amenities of the area through which the road runs.

Tavistock Street and Valley Road, Crown way and Mason Avenue

Due to an administrative error it is necessary to revoke and replace the orders referring to Variation No. 4 Order 2019 and Variation No. 5 Order 2020. This will aid in enforcement and thereby aiding in preserving or improving the amenities of the area through which the roads run.

3. Schedule

Radford Road, Leamington Spa – Footway Parking, Permit Holders L7 Only

- (i) South side from a point 45 metres east of its junction with St Marys Road, eastwards for 18 metres
- South side from a point 73 metres east of its junction with St Marys Road, eastwards for 5 metres
- South side from a point 15 metres west of its junction with St Marys Road, westwards for 9 metres
- (iv) South side from a point 37 metres west of its junction with St Marys Road, westwards for 11 metres
- (v) South side from a point 23 metres east of its of its junction with Clapham Terrace, eastwards for 10 metres

Radford Road, Leamington Spa – No Waiting at any Time

- (i) South side from a point 24 metres west of its junction with St Marys Road, westwards for 13 metres
- (ii) South side from a point 48 metres west of its junction with St Marys Road, westwards for 6 metres

Radford Road, Leamington Spa – L7 permit eligibility

(i) 34 – 94a, even numbers only

Crown Way, Learnington Spa - No Waiting at any Time

(i) South-west side from the roundabout junction between Valley Road and Crown Way, north-westwards for 15 metres

Valley Road, Leamington Spa – No Waiting at any Time

(i) Both sides from the roundabout junction between Valley Road and Crown Way, south-westwards for 15 metres

Mason Avenue, Leamington Spa – No Waiting at any Time

(i) South-west side from the roundabout junction between Valley Road and Mason Avenue, south-eastwards for 15 metres

Tavistock Street (cul-de-sac), Leamington Spa – No Waiting at any Time

(i) Both sides, from its junction with Tavistock Street Westwards for its entire length
