THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON-STREET PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 7) ORDER 2021

Warwickshire County Council propose to make the above Order under the Road Traffic Regulation Act 1984 the effect of which will be to vary the existing Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) Order 2017, as described in the schedule below.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

SCHEDULE

1. Unnamed Road (north) off Gallows Hill - No Waiting At Any Time

From a point on the northern side of the junction with unnamed road (north) in line with the back of the footway on Gallows Hill, in a generally northern direction for 84.0m.

2. Unnamed Road (south) off Gallows Hill - No Waiting At Any Time

From a point on the southern side of the junction with unnamed road (south) in line with the back of the footway on Gallows Hill, in a generally southern direction for 56.5m.

3. Gallows Hill – No Stopping At Any Time Except Authorised Vehicles

An area on the south side of Gallows Hill, 25.0m west of the junction with Unnamed Road (south) for a distance of 16.0m in a northwesterly direction.
