**(CONSOLIDATION) (VARIATION NO.4) ORDER 2021**

The Warwickshire County Council (hereinafter referred to as “the Council”) in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 32, and 35 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as “the 1984 Act”) and of all other enabling powers, hereby make the following Order:-

**PART I**  
**CITATION AND INTERPRETATION**

1. The Warwickshire County Council (Borough of North Warwickshire) (Waiting Restrictions and On-Street Parking Places) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as ‘the Principal Order’) is hereby further varied in the manner and to the extent hereinafter provided.
2. In Article 2 to the Principal Order, delete the definition of “plans” entirely, and replace with the following definition:-

“Plans” means the plans attached to this Order and listed in Schedule 1;
3. In Article 7 to the Principal Order, after the words “no waiting”, insert the words “or “limited waiting””.
4. In Part II to the Principal Order, delete Article 8 entirely, and replace with:-

“8. Save as provided within Article 9, no person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit a vehicle to wait:-

  - (a) in those lengths of road identified on the Plans as “No Waiting” during the periods of time identified on the Plans in relation to that length of road; or
  - (b) in the case of a length of road identified on the Plans as “Limited Waiting”, for longer than the maximum period specified on the Plans in relation to that length of road and provided that the number of hours specified on the Plans for returning to wait in that length of road has elapsed since the termination of the last period of waiting (if any) by that vehicle on that length of road.”
5. After Article 9(2) to the Principal Order, insert:-

“(3) Nothing in Article 8 shall render it unlawful to cause or permit a Disabled Person’s Vehicle which displays in the Relevant Position a Disabled Person’s Badge to wait in the lengths of road identified on the Plans as “Limited Waiting”.”

6. In Article 12(2) to the Principal Order, replace the term “parking space” with the term “Parking Space” where it appears twice.
7. In Schedule 1 to the Principal Order, after the plan titles described in column 1 of the Schedule below, replace the revision numbers with the revision number relating to the corresponding plan as described in column 2 of the Schedule below.
8. In Schedule 1 to the Principal Order, insert plan title “AK47” with Revision No. “0” and plan title “BI37” with Revision No. “0”
9. In the Principal Order, replace the plans attached thereto which are listed in column 1 of the Schedule below, with the plans attached to this Order and listed in column 2 of the Schedule below.
10. To the Principal Order, attach the two new plans which are attached to this Order and numbered “AK47 Revision No. 0” and “BI37 Revision No. 0”.
11. This Order shall come into operation on the            day of            Two thousand and twenty-one and may be cited as “The Warwickshire County Council (Borough of North Warwickshire) (Waiting Restrictions and On-Street Parking Places) (Consolidation) (Variation No. 4) Order 2021”.
