### **ROAD TRAFFIC REGULATION ACT 1984**

# THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, SHUTTINGTON) (30MPH SPEED LIMIT) ORDER 2022

Warwickshire County Council has made the above-named Order under the Road Traffic Regulation Act 1984, the effect of which:

- imposes a 30mph speed limit on the lengths of roads in Shuttington, as described in Schedule 1 below; and
- revokes the 30mph speed limit imposed by The Warwickshire County Council (Restricted Road) (Main Road, Shuttington) Order 1974, leaving the 30mph speed limit in place by virtue of existing street lighting, on the lengths of roads in Shuttington, as described in Schedule 2 below.

The Order commences on Monday 17<sup>th</sup> January 2022.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

#### SCHEDULE 1

### 1. Main Road, Shuttington

- (i) From a point in line with the south west facing flank wall of the Parish Hall, in a south westerly direction along Main Road, for a distance of of 38.5 metres.
- (ii)From a point 62 metres south west of the boundary line between properties number 22 and 24 Main Road, in a north easterly direction along Main Road for a distance of 9metres.

# 2. New Road, Shuttington

(i) From a point 21 metres north west of the boundary line between properties number 35 and 37 New Road, in a north westerly direction along New Road for a distance of 53 metres

# SCHEDULE 2

## 1.Main Road Shuttington

(i) That length of main road in the Parish of Shuttington which extends from a point 63 metres south-west of its junction with Milner Drive, north-eastwards, for a distance of 280 metres.
