ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (A435 STUDLEY COUGHTON AND ALCESTER) (RESTRICTED ROAD REVOCATION, 40MPH & 50MPH SPEED LIMIT) ORDER 2022

The Warwickshire County Council in exercise of its powers under section 82,83 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (and of all other enabling powers) hereby make the following Order: -

- 1. Save as provided in Article 8 below, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road described in the Schedule 1 to this Order.
- 2. Save as provided in Article 8 below, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road described in the Schedule 2 to this Order.
- 3. The Warwickshire County Council (50 m.p.h. Speed Limit) (A.435 Coughton and Sambourne) Variation No. 2) Order 2012 is hereby revoked.
- 4. The Warwickshire County Council (50 m.p.h Speed Limit (A.435 Coughton and Sambourne) Order 1998 is hereby revoked.
- 5. The Warwickshire County Council (A435 Alcester Road/A435 Birmingham Road and A448 Bromsgrove Road, Studley) (Restricted Road) Order 2014 is hereby revoked.
- 6. The Warwickshire County Council (Various Roads, District of Stratford on Avon) (Restricted Roads) Order 2009 is hereby revoked.
- 7. The Warwickshire County Council (40 M.P.H Speed Limit) (A.435 Birmingham Road, Alcester) Order 1987 is hereby revoked.
- 8. The provisions of Article 1 and Article 2 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
- This Order may be cited as "The Warwickshire County Council (A435 Studley Coughton and Alcester) (Restricted Road Revocation, 40mph & 50mph Speed Limit Order 2022" and shall come into operation on the day of Two Thousand and Twenty Two.

SCHEDULE 1

40 MPH

1. A435 Birmingham Road, Coughton-Alcester

From a point 683 metres north of the centreline of its junction with Coughton Fields Lane to a point 194 metres north of the centreline of its junction with Ragley Mill Lane; including the roundabout junction with the B4090 Alcester Heath Road and B4089 Kinwarton link road, known locally as the Birmingham Road Round about; a distance of 2960 metres.

2. A435/A46 Alcester Bypass

The A435 in a north-easterly direction from a point 150 metres south-west of the centre point of its roundabout junction with the B4090 Alcester Heath Road and B4089 Kinwarton Link Road

SCHEDULE 2

<u>50 MPH</u>

1. A435 Alcester Road / Spernal Ash / Haydon Way / Birmingham Road

From a point 36 metres south of the centreline of its junction with Spernal Lane to a point 683 metres north of the centreline of its junction with Coughton Fields Lane; a distance of 1260 metres
