The Secretary of State for Transport in exercise of the powers conferred by section 82(2), 83(1) and 84(1)(a) and (2) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:

- 1. This Order may be cited as the A435 Trunk Road (Gorcott Hill to Studley, Warwickshire) (Restriction and 40 Miles Per Hour Speed Limit) Order 200 and shall come into force on 2 December 2002.
- 2. The length of the A435 Trunk Road between points 285 metres and 406 metres south west of its junction with the centreline of Icknield Street Drive shall be a restricted road for the purposes of section 81 of the Road Traffic Regulation Act 1984.
- 3. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on a length of the A435 Trunk Road from a point 300 metres north east of its junction with the centreline of Common Lane to a point 285 metres south west of its junction with the centreline of Icknield Street Drive.
- 4. Any order under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act which provided that the trunk road or any part thereof should cease to be a restricted road is amended by excluding any reference to the lengths of trunk road described in articles 2 and 3 of this Order

THE A435 TRUNK ROAD (GORCOTT HILL TO STUDLEY, WARWICKSHIRE) (RESTRICTION AND 40 MILES PER HOUR SPEED LIMIT) ORDER 2002

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 82(2), 83(1) and 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 on the A435 Trunk Road between Gorcott Hill and Studley in the County of Warwickshire.

The effect of the Order, which comes into force on 2 December 2002, will be to impose –

- (a) a 30 miles per hour speed limit on the trunk road between points 285 metres and 406 metres south west of its junction with the centreline of Icknield Street Drive, and
- (b) a 40 miles per hour speed limit on the A435 trunk road from a point 300 metres north east of its junction with the centreline of Common Lane to a point 285 metres south west of its junction with the centreline of Icknield Street Drive

STATEMENT OF REASONS

In the five year period between 1/2/96 and 31/1/01, a total of 19 personal injury accidents have occurred on the A435 between Gorcott Hill and Studley.

For safety reasons the existing 60 miles per hour speed limit is to be lowered to 40 mph from Gorcott Hill to north of Studley. The lower speed limit is more appropriate to the character of the road, which includes frontage development, numerous junctions and restricted visibility on the bends through Mappleborough Green. The Order will also extend the existing 30 mph speed limit north of Studley.

To help enforce the lower speed limits mobile speed cameras are to be installed, in partnership with Warwickshire Constabularly.
