THE WARWICKSHIRE COUNTY COUNCIL (A435 ALCESTER ROAD /  
A435 BIRMINGHAM ROAD AND A448 BROMSGROVE ROAD, STUDLEY)  
(RESTRICTED ROAD) ORDER 2014

The Warwickshire County Council, in exercise of its powers under sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. The lengths of road specified in the Schedule to this Order shall be Restricted Roads for the purposes of Section 81 of the Act.
2. This Order may be cited as "The Warwickshire County Council (A435 Alcester Road / A435 Birmingham Road and A448 Bromsgrove Road, Studley) (Restricted Road) Order 2012" and shall come into operation on the Seventh day of April Two thousand and fourteen.

SCHEDULE

(Lengths of roads to be Restricted Roads)

1. A435 Alcester Road / A435 Birmingham Road

From a point 37 metres south of its junction with Sernal Lane, northwards for a distance of 138 metres.

2. A448 Bromsgrove Road, Studley

From its junction with the A435 Alcester Road / A435 Birmingham Road, north-westwards for a distance of 42 metres.

1. The Warwickshire County Council (A448 Sambourne and Studley) (40 m.p.h. and 50 m.p.h. Speed Limits) Order, 2001 (which said Order is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
2. In the Schedule to the Principal Order, Schedule 1 with:-

**SCHEDULE 1**  
**(40 m.p.h. speed limit)**

**A448 Bromsgrove Road, Studley**

From a point 42 metres north-west of its junction with the A435 Birmingham – Alcester Road, north-westwards for a distance of 2428 metres."

3. This Order may be cited as "The Warwickshire County Council (A448 Sambourne and Studley) (40 m.p.h. and 50 m.p.h. Speed Limits) (Variation No. 1) Order 2012" and shall come into operation on the Seventh day of April Two thousand and fourteen.

1. The Warwickshire County Council (50 m.p.h. Speed Limit) (A435 Coughton and Sambourne) Order, 1988 (as varied) (which said Order as varied is hereinafter referred to as "the Principal Order") is hereby further varied in the manner and to the extent hereinafter provided.
2. In the Principal Order, delete the Schedule and replace with:-

**"SCHEDULE**

That length of the A435 Birmingham-Evesham Road which extends from a point 683 metres north of the centreline of Coughton Fields Lane, Coughton, to a point 37 metres south of its junction with Sernal Lane, Studley (being a total distance of approximately 1977 metres)."

3. This Order may be cited as "The Warwickshire County Council (50 m.p.h. Speed Limit) (A435 Coughton and Sambourne) (Variation No. 3) Order 2012" and shall come into operation on the Seventh day of April Two thousand and fourteen.
