## ROAD TRAFFIC REGULATION ACT 1984

### The Warwickshire County Council (Various Roads, Shuttington)

#### (30mph Speed limit) Order 2021

## 1. BACKGROUND

- 1.1 A request from the Parish Council to extend the existing 30mph on Main Road and New Road has been received. After due consideration this has resulted in the proposals below.

## 2. STATEMENT OF REASONS

### 2.1 Main Road & New Road, Shuttington

From the Parish Council via their elected County Cllr (*prior to May 2021 elections*), a request to extend the existing 30mph speed limits has been received.

Currently, there is a 30mph speed limit under The Warwickshire County Council (Restricted Road) (Main Road, Shuttington) Order from 1974 in place along Main Road. It is proposed that the 1974 Order is revoked, which affects the length of road described in Schedule 2 below, leaving a 30mph speed limit in place by virtue of street lighting; which is in accordance with guidance from the Department for Transport.

It is proposed two new short lengths of 30mph are introduced at the village extremities, on Main Road and New Road, as described in Schedule 1 below. Those new 30mph extents are outside of the street lit area and will have to be imposed by a new 30mph Order.

Other road lengths in Shuttington already have a 30mph speed limit in place by virtue of the Street Lighting.

Extending the 30mph speed limit out from the village by these relatively short lengths should have the effect of slowing motorists down prior to entering the urbanised lit areas which should make signs / pedestrians more conspicuous and aid road safety,

and therefore avoid danger to persons or other traffic using the road or to prevent the likelihood of any such danger arising.

## SCHEDULE 1

### 1. Main Road, Shuttington

(i) From a point in line with the south west facing flank wall of the Parish Hall, in a south westerly direction along Main Road, for a distance of 38.5 metres.

(ii) From a point 62 metres south west of the boundary line between properties number 22 and 24 Main Road, in a north easterly direction along Main Road for a distance of 9 metres.

### 2. New Road, Shuttington

(i) From a point 21 metres north west of the boundary line between properties number 35 and 37 New Road, in a north westerly direction along New Road for a distance of 53 metres.

## SCHEDULE 2

### 1. Main Road Shuttington

(i) From a point 63 metres south-west of its junction with Milner Drive, north-eastwards, for a distance of 280 metres.
