SCHOOL ROAD, SALFORD PRIORS Proposed Speed Cushions & Build-outs (Section 90A and 90G Highways Act 1980)

1. STATEMENT OF REASONS

1.1.1 Warwickshire County Council is proposing to install:

-five sets of 2No speed cushions measuring approximately 1.6m to 1.75m (width) x 3m (length) x 0.075m (height) (the width varies to take into account the different road widths) on the lengths of road described in Schedule 1 below: and

-one new Build-out (BO 2) on the length of road described in Schedule 2 below.

The existing Build-out on School Road, Salford Priors, referred to as BO 3 in Schedule 3 below, is to be removed; and the other existing Build-out, referred to in Schedule 4 as BO 1, is to remain.

- 1.2 Prior to construction of the new Priors Crescent Development Stratford District Council made a Planning Condition that a system of traffic calming was required.
- 1.2 The combination of these elements should have the effect of slowing motorists down to assist turning traffic at the new junctions, preserve visibility and aid road safety.

Proposed Speed Cushions, School Road, Salford Priors

5 Sets with 2No. Cushions per Set

- (i) Set 1 located 2 metres south east of the property boundary between No's 31 &32 School Road- Each Cushion 1.75m (width) x 3m (length) x 0.075m (height)
- (ii) Set 2 located opposite property No 20 School Road- Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (iii) Set 3 located. 10m south east of the north west facing flank wall of the Primary School, on School Road—Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (iv) Set 4 located 99.5m south east of the north west facing flank wall of the Primary School, School Road- Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (v) Set 5 located 104m north west of the centre line of Ban Brook Road-- Each Cushion 1.60m (width) x 3m (length) x 0.075m (height)

SCHEDULE 2

Proposed New Build-out, School Road, Salford Priors.

(i) BO 2 - located 49.5m north west of the centre line of Ban Brook Road

SCHEDULE 3

Build-out to be removed, School Road, Salford Priors

(i) BO 3 - existing Build-out to located 60m south east of the north west facing flank wall of the Primary School to be removed.

SCHEDULE 4

Build-out to remain, School Road, Salford Priors

(i) BO 1 - existing Build-out, located just north west of the St Matthews Road Junction with School Road, to remain.
