**SCHOOL ROAD, SALFORD PRIORS**  
**PROPOSED SPEED CUSHIONS AND TRAFFIC CALMING MEASURES**

Warwickshire County Council proposes to install:

- 5 no. sets of speed cushions pursuant to Section 90A of the Highways Act 1980, upon those lengths of road as described in Schedule 1 below; and
- A traffic calming measure (a build out) pursuant to Section 90G of the Highways Act 1980, upon those lengths of road as described in Schedule 2 below.

**PROPOSED SPEED CUSHIONS - SCHOOL ROAD, SALFORD PRIORS**

5 Sets with 2No. Cushions per Set

- (i) Set 1 – located 2 metres south east of the property boundary between No's 31 & 32 School Road- Each Cushion 1.75m (width) x 3m (length) x 0.075m (height)
- (ii) Set 2 – located opposite property No 20 School Road- Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (iii) Set 3 - located. 10m south east of the north west facing flank wall of the Primary School, on School Road- Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (iv) Set 4 - located 99.5m south east of the north west facing flank wall of the Primary School, School Road- - Each Cushion 1.70m (width) x 3m (length) x 0.075m (height)
- (v) Set 5 - located 104m north west of the centre line of Ban Brook Road-- Each Cushion 1.60m (width) x 3m (length) x 0.075m (height)
