PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 7) ORDER  
2022**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In Schedule 2 to the Principal Order, after plan title "FW26", replace the revision number with the revision number "2".
3. In Schedule 2 to the Principal Order, after plan title "FX26", replace the revision number with the revision number "2".
4. In Schedule 2 to the Principal Order, after plan title "FY26", replace the revision number with the revision number "1".
5. In Schedule 2 to the Principal Order, after plan title "GM79", replace the revision number with the revision number "1".
6. In Schedule 2 to the Principal Order, after plan title "GM80", replace the revision number with the revision number "2".
7. In Schedule 2 to the Principal Order, after plan title "HN36", replace the revision number with the revision number "2".
8. In Schedule 2 to the Principal Order, after plan title "HN37", replace the revision number with the revision number "3".
9. In Schedule 2 to the Principal Order, after plan title "HQ36", replace the revision number with the revision number "2".

18. In Schedule 1 of the Principal Order, under the heading ‘Zone S5’ insert the following street:  

“Evesham Road, Nos. 1-38 inclusive”
19. In Schedule 2 to the Principal Order, replace those plans listed in column 1 of the Schedule 1 below with the plans which are listed in column 2 of the said Schedule 1 below and attached to this Order.
20. In Schedule 2 to the Principal Order add the plans attached hereto and listed in Schedule 2 below.
21. This Order shall come into operation on the        day of        Two thousand and twenty two and may be cited as “The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents’ Parking) (Consolidation) (Variation No. 7) Order 2022”
